

Sub:- Diversion of 0.047 ha of Revenue forest land in village Kirarama under Lakhanpur Tahsil of Jharsuguda District in Jharsuguda Forest Division for construction of Link Road to residential-cumoffice Complex of CMPDI Exploration Camp at village Kirarama under Lakhanpur Tahasil in Jharsuguda District at Kirarama by M/s CMPDI Ltd.

Sir,

I am directed to refer to State Govt. letter No.FE-DIV-FLD-0061-2021-7379/FE&CC dated 09.04.2021, wherein prior approval of the Ministry of Environment, Forest & Climate Change for diversion 0.047 ha of Revenue forest land in village Kirarama under Lakhanpur Tahsil of Jharsuguda District in Jharsuguda Forest Division for construction of Link Road to residential-cum-office Complex of CMPDI Exploration Camp at village Kirarama under Lakhanpur Tahasil in Jharsuguda District at Kirarama by M/s CMPDI Ltd., was sought in accordance with Section-2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. After due consideration of the proposal by the Ministry of Environment, Forest & Climate Change, the *in-principle* approval for diversion of the said forest land was accorded by Ministry vide this office letter of even number dated 04.05.2021, subject to fulfillment of certain conditions. The Nodal Officer (FCA) of the State Government has furnished the compliance report in respect of the conditions stipulated in the in-principle approval and has requested to grant final approval of the proposal.

2. In this connection, I am directed to say that on the basis of the compliance report furnished by the PCCF & Nodal Officer (FCA), Odisha vide their letter No.20406/9F (Road)-316/2021 dated 13.10.2023 and uploading of the compliance report in *Parivesh* web portal on 14.05.2024, *Stage-II/final* approval of the Ministry of Environment, Forest & Climate Change is hereby granted under Section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for diversion of 0.047 ha of Revenue forest land in village Kirarama under Lakhanpur Tahsil of Jharsuguda District in Jharsuguda Forest Division for construction of Link Road to residential-cum-office Complex of CMPDI Exploration Camp at village Kirarama under Lakhanpur Tahasil in Jharsuguda District by M/s CMPDI Ltd., subject to the fulfillment of the following conditions:-

A: Conditions which need to be complied prior to handing over of forest land.

- i) The State Govt. shall ensure the compliance on FRA, 2006 as per Forest (Conservation) Rules and guidelines issued from time to time.
- ii) The State Govt. shall ensure that the user agency shall obtain the Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required.
- iii) The State Govt. shall ensure that NPV of the above proposal has been realized from user agency as per Ministry's direction from time to time.
- iv) The State Govt. shall ensure that the KML files of the area to be diverted shall be uploaded on the e-Green watch portal with all requisite details before handing over of the diverted forest land to the user agency.

- v) The State Govt. shall ensure that the boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates.
- B: Conditions which need to be complied after handing over of forest land to the user agency.
- i) Legal status of the diverted forest land shall remain unchanged.
- The State Govt. shall ensure that the State Forest Department shall carry out plantation of 100 trees towards compensatory afforestation within two years from the date of Stage-II Clearance as per agency. The species to be planted under the CA scheme shall be of native species of the area. At done and documented using Geo tagging so that the increase of canopy density and survival and growth of plantation can be evaluated at regular intervals.
- The State Govt. shall ensure that the user agency shall use fly ash for the road construction and for of top soil over it as per Fly Ash Notification No. S.O. 254 (E) dated 25.01.2016.
- The State Govt. shall ensure that the user agency shall submit an undertaking to ensure that flanks

- v) The State Govt. shall ensure that no labour camp shall be established on the forest land and the user agency shall provide fuels preferably alternate fuels to the labourers and staff working at the site so vi) The State Govt, and user agency by the state Govt, and user agency by the state Govt.

 vii) The State Govt. and user agency shall ensure that no additional or new path will be constructed
- vii) The State Govt. and user agency shall ensure that while executing works, the user agency shall not fell any tree or damage forest growth in the surrounding forest area in any manner.
- viii) The State Govt. shall ensure that the period of diversion under this approval shall be co-terminus ix) The State Govt and user agency of the project life, whichever is less.
- ix) The State Govt, and user agency shall ensure that earth or any material shall neither be brought user agency.

- x) The State Govt. and user agency shall ensure that the layout plan of the proposal shall not be changed without prior approval of the Ministry of Environment, Forest & Climate Change.
- The State Govt. shall ensure that the forest land shall not be used for any purpose other than that department or person without prior approval of the Ministry of Environment, Forest & Climate Change.
- xii) The State Govt. shall ensure that no damage to the flora and fauna of the adjoining area shall be caused.
- xiii) The State Govt. shall ensure that the DFO concerned will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in surrounding area.
 xiv) The State Govt. shall ensure that the properties of the state of the sta
- xiv) The State Govt. shall ensure that the user agency shall submit annual self monitoring report on Office of this Ministry by the end of March every year regularly.

 xv) The State Govt, shall ensure the content of the State and Integrated Regional (xv).
- The State Govt. shall ensure that any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, which shall be complied by the user agency.

- The State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, xvi) Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as prescribed in Para 1.16 of Chapter 1 of the Consolidated Guidelines and Clarification issued under Van (Sanrakshna Evam Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023 by this Ministry's letter dated 29.12.2023.
