**विषय/Subject: Diversion of 0.33 ha of forest land in Arambi Reserved Forests for formation of road to combined court complex at Udagamandalam in Nilgiris District in favour of District Court, Udagamandalam, the Nilgiris District-Reg.**

महोदय/Madam,

Please refer to the State Government's letter No. 6324/FR10/2022-1 dated 04.05.2022 and online proposal No.FP/TN/ROAD/101799/2020, seeking prior approval of the Central Government for diversion of forest land in accordance with Section 2(1) of Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 for the above-mentioned project. The project was accorded In-principle approval (Stage-I) by the Central Government letter of even No. dated 06.05.2022. The State Government *vide* letter No. 6324/FR10/2022-3 dated 30.04.2025 reported compliance to the conditions stipulated in the In-principle approval.

After careful consideration of the proposal of the State Government, I am hereby directed to convey the Central Government's **Final approval (Stage-II)** under Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980, for the **diversion of 0.33 ha of forest land in Arambi Reserved Forests for formation of road to combined court complex at Udagamandalam**

**in Nilgiris District in favour of District Court, Udagamandalam, the Nilgiris District**, subject to the following conditions:-

- (i) Legal status of the diverted forest land shall remain unchanged;
- (ii) **The State Forest Department shall carry out plantations and its maintenance over the extent of 3.07 ha of DFL area in Compt. No. 872 of Wenlockdown RF, Udhagai, North Range, at the cost of Rs. 56,37,503/- which was already realized from the User Agency;**
- (iii) Approved CA Scheme and CA area shall not be changed without the prior approval of Govt. of India. The work of CA shall start within two years of issue of final order of diversion as per provision Rule 14(2) of Van (Sanrakshan Evam Samvardhan) Rules, 2023.
- (iv) Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency.
- (v) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- (vi) No labour camp shall be established on the forest land.
- (vii) Disturbance shall be kept minimal by creating labour camps outside the forest area as far as possible and it will be the responsibility of the User Agency to ensure that the machinery, labourers & staff engaged in execution of work shall not destruct nearby forest flora & fauna;
- (viii) Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- (ix) **Felling of trees shall be under strict supervision of the DFO concerned and no spontaneous trees shall be felled;**
- (x) The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, department or person without prior approval of the Central Government;

- (xi) The total forest area utilized for the project shall not exceed **0.33 ha** and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal;
- (xii) User Agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project;
- (xiii) Any other conditions that the Central Government or Regional Officer(Central) of the Regional Office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the User Agency;
- (xiv) Violation of any of the above conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam 1980 and action would be taken as per Rules and Guidelines issued under the Adhiniyam;
