Subject: Diversion of 2.18 ha. of forest land (1.25 ha. within the existing RoW in 6 stretches & 0.93 ha. not covered in RoW in 3 stretches) for laying underground Optical Fiber Cable along the road passing through forests of Narsipatnam Division in favour of M/s. Reliance Jio Infocomm. Ltd., Visakhapatnam for providing 4G Communication in the State of Andhra Pradesh-Reg

Sir,

Please refer to the State Government's letter No. 3510/Section.II/2019/(1021986) Dated: 03.02.2023 and online proposal No. FP/AP/OFC/36777/2018 seeking prior approval of the Central Government for diversion of forest land in accordance with Section '2(1)' of Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 for the above mentioned project. The project was accorded in-principle approval by the Central Government vide letter F.No. 4-APB098/2020-CHN/1061 dated 19.07.2023. The State Government vide letter No. 3510/Section.II/2019/1021986 Dated: 03.05.2024 has reported compliance to the conditions stipulated in the in-principle approval.

After careful consideration of the proposal of the State Government, I am directed to convey the Central Government's final approval under Section '2(1)' of Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 for diversion of **2.18 ha.** of forest land (1.25 ha. within the existing RoW in 6 stretches & 0.93 ha. not covered in RoW in 3 stretches) for laying underground Optical Fibre Cable along the road passing through forests of Narsipatnam Division in favour of M/s. Reliance Jio Infocomm. Ltd., Visakhapatnam for providing 4G Communication in the State of Andhra Pradesh, subject to the following conditions:-

- i. Legal status of the diverted forest land shall remain unchanged;
- ii. Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at the cost of the User Agency;

- iii. The State Forest Department shall carry out compensatory afforestation over an extent of i.e. 4.71 ha of degraded forest area in Compt No 1206 & 1208 Arilova RF Arilova Beat, Narsipatnam Range Analapalli Division at the cost of the User Agency;
- iv. Identified CA area and CA scheme shall not be changed without prior approval of Central Government;
- v. Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency;
- vi. No tree felling shall be carried out in the forest area;
- vii. No additional / new path shall be made during execution of the project;
- viii. The forest land shall be restored to its original state after laying the same;
- ix. The dug out material / overburden shall be dumped outside the forest area. Storage of any material shall not be done in the forest; area;
- x. The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- xi. The User Agency shall provide firewood preferably alternate fuel to labourers working at the site to avoid damage/tree felling and no labour camp shall be established inside the forest area;
- xii. Disturbance shall be kept minimum by creating labour camps outside the forest area as far as possible and it shall be the responsibility of the User Agency to ensure that the labourers & staff engaged in execution of work do not destruct nearby forest flora & fauna;
- xiii. The total forest area utilized for the project shall not exceed **2.18** and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal;
- xiv. The forest land proposed for diversion shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government;
- xv. The User Agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project;
- xvi. Any other conditions that the Central Government may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency;
- xvii. The conditions required to be adhered under the Forests Right Act, 2006 as per the guidelines issued under Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 shall be strictly complied with;
- xviii. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 and action would be taken as prescribed under the Act, Rules and Guidelines relevant.
