विषय: Proposal for diversion of 0.35 Ha forest land for Construction of 6 Lane access controlled Highway from DND Maharani Bagh to Junction with Jaitpur-Pushta Road Section of NH-148 NA in the NCR of Delhi (PKG - I) under Bharatmala Pariyojana-reg.

संदर्भ: प्रधान मुख्य वन संरक्षक का पत्रांक 22/FCA/NHAI/0.35 ha/2022-23/ 9844-49, दिनांक 03.11.2025.

महोदय,

कृपया उपरोक्त विषयक प्रमुख सचिव (पर्यावरण एवं वन), दिल्ली सरकार के अनुशंसा पत्र दिनांक 27.06.2022 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रकरण में वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 के अन्तर्गत भारत सरकार की स्वीकृति मांगी गयी थी।

प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 26.07.2022 द्वारा कतिपय शर्तों के साथ सैद्धांतिक स्वीकृति प्रदान की गई थी, जिसकी अनुपालना उपरोक्त संदर्भित पत्र के माध्यम से प्रेषित की गई है। प्रस्तुत अनुपालना के परीक्षणोपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 0.35 हे० वनभूमि के प्रत्यावर्तन एवं 200 वृक्षों के पातन व 07 वृक्षों के translocation की विधिवत् स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है-

1. Legal status of the forest land shall remain unchanged.
2. Compensatory afforestation shall be taken up by the Forest Department over 0.35 ha of non-forest land at Khasra No. 37//14/1 min, 37//14/2 min, 37//15/2 min, 37//16/1 min and 28//25/2, 36//6/2 min, 36//9/1 min, 36//9/2/2 min, 36//12/1 min, 36//12/2 min, 36//30 min, Village- Badrpur, Tehsil - Sarita Vihar, Range South Forest Division, Dist.-South East Delhi, Delhi at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and mono-culture of any species may be avoided.
3. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
4. User agency shall restrict the felling of trees to 200 trees/minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
5. Forest land will be handed over only after required non-forest land (0.35 ha.) for the project is handed over by the user agency.
6. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/Forest Areas.
7. The user agency shall provide suitable under / over pass in Protected Area / Forest Area as per recommendations of CWLW / NBWL / FAC / REC.
8. The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
9. The layout plan of the proposal shall not be changed without prior approval of Central Government.
10. No labour camp shall be established on the forest land.
11. The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.

12. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
13. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
14. **The period of diversion under this approval shall be for 99 years or co-terminus with the period of the project life, whichever is earlier.**
15. **The State Government shall ensure necessary action subsequent to any change in forest area/forest boundary after completion of digitization.**
16. **DFO shall ensure that the area proposed for diversion is as per the existing Working Plan and no other affected forest area is left to be included in the proposal.**
17. The forest land shall not be used for any purpose other than that specified in the project proposal.
18. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
19. **The KML file of area proposed for diversion and area proposed for plantation shall be uploaded on the E-Green watch portal with all requisite details before commencement of works.**
20. Annual 3rd party monitoring and concurrent internal monitoring by State Forest Department shall be done and monitoring reports submitted to this office.
21. The User Agency and the State Government shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
22. Project Completion Report and Stage-II compliance report shall be submitted within a period of 6 months of completion of project.
23. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as per para 1.16 of consolidated guideline and clarifications on Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023, MoEF&CC and as amended form time to time.
24. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
25. This approval is subject to the final outcome with respect to Hon'ble Supreme Court Orders in the CWP (C) No 1164/2023 dated 3.2.2025 and 04.03.2025.
