विषय:- Final (Stage-II) approval of Central Government under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for proposed diversion of 0.95 ha forest land in favour of Damodar Valley Corporation for construction of 33 KV Transmission Line for 2.2 MVA power supply to Garrison Engineers (MES) from DVC's Ramgarh substation in Ramgarh Forest Division, Jharkhand – reg.

महाशय,

I am directed to refer to you the Jharkhand Govt. letter No.Van Bhumi-20/2023-3692/Va.Pa. dated 29.09.2023, wherein prior approval of Ministry of Environment, Forest and Climate Change for diversion of 0.95 ha forest land in favour of Damodar Valley Corporation for construction of 33 KV Transmission Line for 2.2 MVA power supply to Garrison Engineers (MES) from DVC's Ramgarh substation in Ramgarh Forest Division, Jharkhand, was sought in accordance with Section-2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. After due consideration of the proposal of the State Government, the 'in-principle' approval of the Central Government for diversion of the said forest land was accorded vide this office letter of even number dated 17.10.2023 subject to fulfillment of certain conditions. The State Government of Jharkhand vides their letter No. Van Bhumi-20/2023-2033/Va.Pa. dated 11.06.2025 have furnished compliance report in respect of the relevant conditions stipulated in the in-principle approval for grant of final approval.

In this connection, on the basis of the compliance report under reference, the **final approval** of the Central Government under Section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is hereby accorded for diversion of 0.95 ha forest land in favour of Damodar Valley Corporation for construction of 33 KV Transmission Line for 2.2 MVA power supply to Garrison Engineers (MES) from

DVC's Ramgarh substation in Ramgarh Forest Division, Jharkhand, subject to the following conditions and stipulations:-

- (1) Legal status of the forest land diverted shall remain unchanged.
- (2) Compensatory afforestation: The State Forest Department shall plant 100 trees to maintain the green cover at the project cost. Planting site for the purpose shall be identified by the State Forest Department preferably in the vicinity of the project site. Indigenous tree species should be preferred for such plantation.
- (3) The complete compliance of the FRA, 2006 shall be ensured by the way of prescribed certificate from the concerned District Collector.
- (4) Wherever possible and technically feasible, the User Agency shall undertake appropriate afforestation measures all around the project site related to this approval, in consultation with the State Forest Department, at the project cost.
- (5) The User Agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter No.7-25/2012-FC dated 5.5.2014, 19.11.2014 & 24.10.2016.
- (6) The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officers.
- (7) No additional or new path will be constructed inside the adjoining forest area for transportation of construction materials for execution of the project work.
- (8) The layout plan of the proposed diversion of the forest land shall not be changed without prior approval of Ministry of Environment, Forest and Climate Change.
- (9)
 - a) No labour camp shall be established inside the forest land.
 - b) The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
 - c) Earth or any other material shall not be brought from and debris resulting during construction shall not be disposed of in the adjoining forest area by the user agency.
- (10)
 - a) The diverted forest land shall not be used for any purpose other than that specified in the project proposal.
 - b) The period of diversion under this approval shall be co-terminus with the period of the project life.

- c) The diverted forest land shall under no circumstances be transferred to any other agencies, department, or person without prior approval of the Ministry of Environment, Forest and Climate Change.
- (11) The State Government shall ensure judicious use of money received by the user agency against this forest diversion proposal in accordance with CAMPA Rules amounting Rs.36,86,900/- towards CA and towards Rs.9,09,891/- NPV.
- (12) The User Agency and the State Government shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any, for the time in force, as applicable to the project.
- (13) Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken accordingly.
- (14) Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests and wildlife.

2. As has been mentioned at Para-2 of the Stage-II approval, this approval for diversion of forest land is subject to the fulfillment of stipulated conditions mentioned in this approval letter. Therefore, in the event of non-compliance of any of the conditions laid out in this approval letter, the Regional Office of Ministry of Environment, Forest & Climate Change may withdraw the said approval for diversion of the forest land and stop the non-forest activity being carried out in the forest land besides initiating the legal action as per provisions of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.
