विषय: बालाघाट जिले में प्रधानमंत्री ग्राम सड़क योजना (RCPLWE) के अन्तर्गत बोदलखा से धीरी मुरुम तक मार्ग निर्माण हेतु 16.533 हेक्टेयर (कुल 16.65 हेक्टेयर वनभूमि में से 0.117 हेक्टेयर वनभूमि को छोड़कर जो कि Wildlife clearance के लिए आवेदित है) आरक्षित वनभूमि, महाप्रबंधक, मध्यप्रदेश ग्रामीण सड़क विकास प्राधिकरण को उपयोग पर देने बाबत (FP/MP/Road/155629/2022) ।

Sir,

I am directed to refer to the PCCF/APCCF (LM) and Nodal Officer, Govt. of Madhya Pradesh letter No. F-5/1256/2023/10-11/1938 dated 12/05/23, 4455 dated 06/10/2023, 1697 dated 20/03/2024 and even letter No. 3384 dated 27/06/24, wherein prior approval of Ministry of Environment, Forest and Climate Change for diversion of 16.533 ha Reserved Forest land for construction of road from Bodalkha to Dhiri Murum under RCPLWEA Scheme in favour of General Manager, Madhya Pradesh Rural Road Development Authority in Balaghat District of Madhya Pradesh, was sought in accordance with Section-2 of the Forest (Conservation) Act, 1980. After due consideration of the proposal of the State Government, the 'in-principle' approval of the Central Government for diversion of the said forest land was accorded vide this office letter dated 30/08/2024 subject to fulfillment of certain conditions. The APCCF (LM), Govt. of Madhya Pradesh vide their letter No. F-5/1256/E-file 0327/2025 dated 05/06/2025 have furnished compliance report in respect of the relevant conditions stipulated in the in-principle approval for grant of final approval.

In this connection, on the basis of the compliance report under reference and confirmation of receipt of compensatory levies from National Authority of CAMPA dated 15/03/2024 & 17/04/2025 the **final approval** of the Central Government under Section 2 of the Forest (Conservation) Act, 1980 is hereby accorded for diversion of 16.533 ha Reserved Forest land for construction of road from Bodalkha to Dhiri Murum under RCPLWEA Scheme in favour of General Manager, Madhya Pradesh Rural Road Development Authority in Balaghat District of Madhya Pradesh, subject to the following conditions and stipulations:-

- (1) Legal status of the forest land diverted shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the Forest Department over **33.30 ha (out of 82.00 ha) Chhote-Bade Jhad ka Jungle at Khasra No. 25/1 क/1, Village-Gummur, Tehsil-Birsa, District- Balaghat** at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species shall be avoided.

- (3) The State Government shall ensure that compliance of Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has been completed in accordance with the relevant Rules and Guidelines issued by the MoEF&CC, GoI in this regard.
- (4) User Agency shall restrict the felling of trees up to **277 enumerated numbers or minimum number** in the diverted forest land and they shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- (5) *The CA area mutated and transferred in favour forest department shall be notified as RF/PF under the provision of IFA, 1927 prior issuing final order by the State Govt and the Nodal Officer shall ensure the uploading of the same in online portal.*
- (6) *The roadside plantation is not possible therefore the fund deposited against roadside plantation shall be utilised for raising plantation in any degraded forest land as per working plan prescription and the details of the area shall be provided to the Regional Office, Bhopal for record purposes.*
- (7) *The User Agency shall strictly follow the conditions of Wildlife clearance imposed by PCCF(WL) & CWLW Madhya Pradesh in the approval letter issued dated 13/01/2025.*
- (8) *The copy of road side plantation scheme shall be submitted to the Regional Office and road side plantation shall be carried out by State Forest Department at the cost of User Agency in accordance with the scheme as per IRC norms.*
- (9) *Backlog of CA shall be cleared in this plantation season and report submitted to this office.*
- (10) *Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas.*
- (11) The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- (12) Boundary of the diverted forest land shall be demarcated on the ground at the project cost, as per the directions of the concerned DFO.
- (13) The layout plan of the proposed diversion of the forest land shall not be changed without prior approval of Central Government.
- (14) No additional or new path will be constructed inside the forest area for execution of the project work.
- (15) No labour camp shall be established inside the forest land.
- (16) The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- (17) The diverted forest land shall not be used for any purpose other than that specified in the project proposal.
- (18) The period of diversion under this approval shall be co-terminus with the period of the project life.
- (19) The diverted forest land shall under no circumstances be transferred to any other agencies, department, or person without prior approval of the Central Government.

- (20) The User Agency shall provide suitable under/ over pass in Protected Area/ Forest Area as per recommendation of CWLW/ NBWL/FAC/ REC, if applicable.
- (21) The User Agency and the State Government shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any, for the time in force, as applicable to the project.
- (22) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- (23) **All the conditions of Stage-I approval dated 30/08/2024 shall be strictly complied.**
- (24) Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests and wildlife.

As has been mentioned at Para-2 of the Stage-II approval, this approval for diversion of forest land is subject to the fulfillment of stipulated conditions mentioned in this approval letter. Therefore, in the event of non-compliance of any of the conditions laid out in this approval letter, the Regional Office of Ministry of Environment, Forest & Climate Change may withdraw the said approval for diversion of the forest land and stop the non-forest activity being carried out in the forest land besides initiating the legal action as per provisions of Forest (Conservation) Act, 1980.
