विषयः जनपद आगरा में यमुना प्रदूषण नियंत्रण इकाई, उ०प्र० जल निगम (ग्रामीण) आगरा द्वारा बांईपुर एवं शहर रेंज के अंतर्गत डी०एस०ए०टी०पी० के निर्माण हेतु बाईपुर वन ब्लाक, बाबरपुर वन ब्लाक, मऊ वन ब्लाक एवं ताज वन ब्लाक की 0.9024 है0 आरक्षित वनमूमि के गैर-वानिकी प्रयोग एवं बिना वृक्ष पातन की अनुमति के सम्बन्ध में।

कृपया उपरोक्त विषयक सचिव (वन), उत्तर प्रदेश शासन के पत्रांक 1008/81-2-2023-800(30)/2023, दिनांक 18.04.2023 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रकरण में राज्य सरकार द्वारा वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 के अन्तर्गत भारत सरकार की स्वीकृति मांगी गयी थी।

प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 02.02.2024 द्वारा कतिपय शर्तों के साथ सैद्धान्तिक स्वीकृति प्रदान की गयी थी, जिसकी अनुपालना उपरोक्त संदर्भित पत्रों के माध्यम से प्रेषित की गई है। प्रस्तुत अनुपालना के परीक्षणोपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार जनपद आगरा में यमुना प्रदूषण नियंत्रण इकाई, उ०प्र० जल निगम (ग्रामीण) आगरा द्वारा बांईपुर एवं शहर रेंज के अंतर्गत डी०एस०ए०टी०पी० के निर्माण हेतु बांईपुर वन ब्लाक, बाबरपुर वन ब्लाक, मऊ वन ब्लाक एवं ताज वन ब्लाक की 0.9024 है0 आरक्षित वनभूमि के गैर-वानिकी प्रयोग एवं बिना वृक्ष पातन की विधिवत् स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:-

- 1. Legal status of the forest land shall remain unchanged.
- Compensatory afforestation shall be taken up by the Forest Department in an area of 0.9024 ha. Non Forest Land (NFL) in Madayna Gram Samaj, Range Fatehabad, District Agra at the cost of the user agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.
- 3. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 4. Forest land will be handed over only after required non-forest land for the project is handed over by the user agency.
- 5. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- 6. The layout plan of the proposal shall not be changed without prior approval of Central Government.
- No labour camp shall be established on the forest land.
- 8. The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- 9. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 10. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.

- 11. The period of diversion under this approval shall be for 30 years or co-terminus with the period of the project life, whichever is earlier.
- 12. The State Government shall ensure necessary action subsequent to any change in forest area/forest boundary after completion of digitization.
- 13. DFO shall ensure that the area proposed for diversion is as per the existing Working Plan and no other affected forest area is left to be included in the proposal.
- 14. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 15. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 16. No any tree felling shall be done in Taj Trapezium Zone (TTZ) area during execution of project works without prior approval of Hon'ble Supreme Court.
- 17. The KML file of area proposed for diversion and area proposed for plantation shall be uploaded on the E-Green watch portal with all requisite details before commencement of works.
- 18. Annual 3rd party monitoring and concurrent internal monitoring by State Forest Department shall be done and monitoring reports submitted to this office.
- 19. Project Completion Report and Stage-II compliance report shall be submitted within a period of 6 months of completion of project.
- 20. The User Agency and the State Government shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
- 21. The violation of any of the conditions stipulated under this approval will be liable to the cognizance and appropriate action under MoEFCC rules and Guidelines as applicable, specifically MoEFCC Guidelines dated 15/05/2023, authorizing officers of the rank of Divisional Forest Officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or Union territory Administration concerned, having jurisdiction over the forest land in respect of which any offence under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is committed or violation of the provisions of the said Adhiniyam has been made, to file complaints against such person/authority/organization, prima-facie found guilty of offence under the Adhiniyam or the violation of the rules made thereunder, in the court having jurisdiction in the matter.
- 22. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, (1980), and action would be taken as per the MoEF&CC Guideline F.No. 11-42/2017-FC dt. 29/01/2018.
- 23. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- 24. This approval is subject to the final outcome with respect to Hon'ble Supreme Court Orders in the CWP (C) No 1164/2023 dated 3.2.2025 and 4.3.2025.
