विषय: खण्डवा एवं बुरहानपुर जिले में भारतमाला परियोजना के अन्तर्गत राष्ट्रीय राजमार्ग 753L के तहत बोरेगांव बुजुर्ग से मुक्ताईनगर फोरलेन मार्ग निर्माण/ चौड़ीकरण हेतु 87.5709 हेक्टेयर (10.6681 हे. वनमण्डल खण्डवा एवं 76.9028 हे. वनमण्डल बुरहानपुर) आरक्षित एवं संरक्षित वनभूमि परियोजना निदेशक, भारतीय राष्ट्रीय राजमार्ग प्राधिकरण को उपयोग पर देने बाबत (FP/MP/ROAD/156438/2022).

I am directed to refer to the APCCF (LM) and Nodal Officer, Govt. of Madhya Pradesh letter No. F-5/1351/2023/10-11/4601 dated 17/10/2023 and 5170 dated 30/11/23 wherein prior approval of Ministry of Environment, Forest and Climate Change for diversion of 87.5709 ha 910.6681 ha Forest Division Khandwa & 76.9028 ha Forest Division Burhanpur) Reserved & Protected Forest land for 4 laning of Indore-Muktainagar Section of NH-753L from Boregaon Buzurg, Khandwa District in M.P. Design Ch. 139+000 to Muktainagar, Jalgaon District in Maharashtra Design Ch. 216+278 (length 77.278 km) under Bharatmala Pariyojana in favour of General Manager, National Highway Authority in Khandwa & Burhanpur Districts of Madhya Pradesh was sought in accordance with Section-2 of the Forest (Conservation) Act, 1980. After due consideration of the proposal of the State Government, the 'in-principle' approval of the Central Government for diversion of the said forest land was accorded vide this office letter dated 29/12/2023 subject to fulfillment of certain conditions. The APCCF (LM), Govt. of Madhya Pradesh vide their letter No. F-5/1351/2023/10-11/1032 dated 14/02/2024 & even letter No. 2084 dated 29/07/2025 have furnished compliance report in respect of the relevant conditions stipulated in the in-principle approval for grant of final approval.

In this connection, on the basis of the compliance report under reference and confirmation of receipt of compensatory levies from National Authority of CAMPA dated 17/01/2024 the **final approval** of the Central Government under Section 2 of the Forest (Conservation) Act, 1980 is hereby accorded for diversion of 87.5709 ha 910.6681 ha Forest Division Khandwa & 76.9028 ha Forest Division Burhanpur) Reserved & Protected Forest land for 4 laning of Indore-Muktainagar Section of NH-753L from Boregaon Buzurg, Khandwa District in M.P. Design Ch. 139+000 to Muktainagar, Jalgaon District in Maharashtra Design Ch. 216+278 (length 77.278 km) under Bharatmala Pariyojana in favour of General Manager, National Highway Authority

in Khandwa & Burhanpur Districts of Madhya Pradesh, subject to the following conditions and stipulations:-

- (1) Legal status of the forest land diverted shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the Forest Department over **180.00 ha degraded-forest land** at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species shall be avoided. Details of Cas are as follows:

- (3) The State Government shall ensure that compliance of Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has been completed in accordance with the relevant Rules and Guidelines issued by the MoEF&CC, GoI in this regard.
- (4) User Agency shall restrict the felling of trees up to **18702 enumerated numbers or minimum number** in the diverted forest land and they shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- (5) The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- (6) Boundary of the diverted forest land shall be demarcated on the ground at the project cost, as per the directions of the concerned DFO.
- (7) The layout plan of the proposed diversion of the forest land shall not be changed without prior approval of Central Government.
- (8) No additional or new path will be constructed inside the forest area for execution of the project work.
- (9) No labour camp shall be established inside the forest land.
- (10) The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- (11) The diverted forest land shall not be used for any purpose other than that specified in the project proposal.
- (12) The period of diversion under this approval shall be co-terminus with the period of the project life.
- (13) The diverted forest land shall under no circumstances be transferred to any other agencies, department, or person without prior approval of the Central Government.

- (14) The User Agency shall provide suitable under/ over pass in Protected Area/ Forest Area as per recommendation of CWLW/ NBWL/FAC/ REC, if applicable.
- (15) The User Agency and the State Government shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any, for the time in force, as applicable to the project.
- (16) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- (17) **All the conditions of Stage-I approval dated 29/12/2023 shall be strictly complied.**
- (18) Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests and wildlife.

As has been mentioned at Para-2 of the Stage-II approval, this approval for diversion of forest land is subject to the fulfillment of stipulated conditions mentioned in this approval letter. Therefore, in the event of non-compliance of any of the conditions laid out in this approval letter, the Regional Office of Ministry of Environment, Forest & Climate Change may withdraw the said approval for diversion of the forest land and stop the non-forest activity being carried out in the forest land besides initiating the legal action as per provisions of Forest (Conservation) Act, 1980.

This has been issued with the approval of the Competent Authority.
