विषयः Diversion of 4.9975 ha of Reserved and Protected Forest land for laying of pipeline Hindoli- Nainwa Water Supply Project District- Bundi from Chambal- Bhilwara WSP (Phase-I) District- Bundi (Rajasthan) in favour of Executive Engineer, Public Health Engineering Department, Rajasthan.

सन्दर्भः शासन सचिव का पत्र क्रमांक प.1(58)वन/2023 दिनांक 01.03.2024 एवं समसंख्यक पत्र दिनांक 30.07.2024 एवं 12.09.2025.

महोदय,

उपरोक्त विषयक शासन सचिव, वन विभाग, राजस्थान सरकार, जयपुर के पत्रांक प.1(58)वन/2023 दिनांक 31.07.2023 का आशय ग्रहण करने का कष्ट करें जिसके माध्यम से राज्य सरकार द्वारा विषयांकित प्रस्ताव पर केन्द्र सरकार से वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा (2) के तहत् स्वीकृति मांगी गयी थी।

प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 10.08.2023 द्वारा सैद्धांतिक स्वीकृति प्रदान की गई थी जिसकी अनुपालना उपरोक्त संदंभित पत्र द्वारा प्रेषित की गयी है। प्रस्तुत अनुपालना के अवलोकन पश्चात्, केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 4.9975 हे0 वनभूमि के प्रत्यावर्तन एवं 329 वृक्षों के पातन की विधिवत् स्वीकृति (Final/ Stage-II Approval) निम्नलिखित शर्तों पर प्रदान करती है:-

- 1. Legal status of the forest land shall remain unchanged.
- 2. Forest land will be handed over only after required non-forest land for the project is handed over to Forest Department and the diverted forest land is demarcated in the field by the user agency.
- 3. Compensatory afforestation shall be taken up by the Forest Department over 4.9975 ha non-forest land identified in Khasra No. 1346, Village- Kota Khurd, District- Bundi, Rajasthan at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 4. The State Government will ensure complete compliance/settlement of RoFR Act, 2006 before issuance of final order for diversion.
- User Agency shall restrict the felling of trees to 329 numbers or less in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department.
- 6. The pipeline shall be laid at 1.5 meter below the ground and after lying down of pipeline, the ground will be leveled.
- 7. All the conditions stipulated by the, CWLW, Govt. of Rajasthan vide letter No. F(1075)WLC/CWLW/2023/646 dated 28.05.2025 based on the clearance given by the SC-NBWL shall be strictly complied with by the User Agency

- under strict supervision of State Forest Department.
- 8. The trees with bird nests, reptiles and habitat of Wildlife was observed, than such tree shall be treated with special care for relocation in the forest land by Forest Department at the cost of User Agency.
- 9. The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 10. No labour camp shall be established on the forest land.
- 11. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 12. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 13. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 14. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 15. The User Agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- 16. All the conditions of Stage-I/ In-principle approval shall be strictly complied.
- 17. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 18. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evem Samvardhan) Adhiniyam, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- 19. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- 20. User agency shall furnish annual self compliance report on the above conditions and the SFD shall monitor the project and submit annual report to the Regional Office, Gandhinagar.
