Sub: Final (Stage-II) approval of Central Government under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for proposed diversion of 1.592 ha Forest land for Construction of Protection Wall with Jampore Ghat for Extension of Jampore Sea Front upto Varliwad School at Jampore - reg.

Sir.

This has reference to online Proposal No. FP/DD/ROAD/143323/2021 of the UT Govt. of Dadra Nagar Haveli, Daman & Diu on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest & Climate Change under section-2 of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. After due consideration of the proposal of the State Government, the 'In-Principle/Stage-I' approval of the Central Government for the diversion of the said forest land was accorded vide this office letter No. FC-6/DDB-73/2023-GNR dated 03.01.2024 subject to fulfillment of certain conditions. The UT Government on dated 04.03.2025 and 22.09.2025 have furnished condition wise compliance report online in respect of the relevant conditions stipulated in the In-principle approval for grant of final approval.

In this connection, on the basis of the compliance report under reference and confirmation of CAMPA receipt transaction dated 16.02.2024, the **Final/Stage-II approval** of the Central Government under Section-2 of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is hereby conveyed for diversion of 1.592 ha Forest land for Construction of Protection Wall with Jampore Ghat for Extension of Jampore Sea Front upto Varliwad School at Jampore subject to the following general and standard conditions:

- 1. Legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up by the Forest Department over

- 1.592 ha non-forest land identified in Survey No. PTS No. 102/1, Village-Fudam, District Diu of Diu and Daman at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species should be avoided.
- 3. User agency shall restrict the felling of trees to 191 trees/minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 4. The trees with bird nests, reptiles and habitat of Wildlife was observed than such tree shall be treated with special care for relocation in the forest land by Forest Department at the cost of User Agency.
- 5. The UT Government will ensure complete compliance of FRA, 2006 before issuance of final order for diversion.
- 6. The KML files of diverted area and CA area are to be uploaded on the e-Green Watch Portal before issuing the orders for diversion by the State
- 7. The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 8. No labour camp shall be established on the forest land.
- 9. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 10. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 11. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 12. The User Agency shall submit the annual self compliance report in respect of the above stated conditions to the State Government and Integrated Regional Office, Gandhinagar by the end of March every year. The UT Forest Department shall monitor the conditions stipulated and submit an annual report to the Regional Office, Gandhinagar.
- 13. The User Agency and SFD shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- 14. All the conditions of Stage-I approval shall be strictly complied.
- 15. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- 16. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.

As has been mentioned at Para-2 of this final approval, this approval for diversion of forest land is subject to the fulfillment of stipulated conditions mentioned in this approval letter.

Therefore, in the event of non-compliance of any of the conditions laid out in this approval letter, the Regional Office of Ministry of Environment, Forest and Climate Change may withdraw the said approval for the diversion of the forest land and

stop the non-forest activity being carried out in the forest land besides initiating the legal action as per provisions of **Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980**.
