**Subject: Diversion of 4.23 ha forest land in Compt No 450 of Yerragonda RF, Tummagunta (V), Kanigiri (M), Prakasham District for excavation of quartz in f/o Sri Ahobila Narasimha Minerals -Reg**

Sir,

Please refer to the State Government's letter Nos. 275/Section -II/2020 dated 14.07.2020 and 275/Section.II/2021/1086660 dated 29.08.2023 and online proposal No. FP/AP/QRY/38806/2019 seeking prior approval of the Central Government for diversion of forest land in accordance with Section '2(1)' of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for the above mentioned project. The project was accorded in-principle approval by the Central Government vide letter F.No. 4-APB103/2020-CHN /1349 dated 01.11.2023. The State Government vide letter No. 275/Section-II/2020/1086660 Dated: 20.09.2024 has reported compliance to the conditions stipulated in the in-principle approval.

After careful consideration of the proposal of the State Government, I am directed to convey the Central Government's final approval under Section '2(1)' of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for diversion of **4.23 ha** forest land in Compt No 450 of Yerragonda RF, Tummagunta (V), Kanigiri (M), Prakasham District for excavation of quartz in f/o Sri Ahobila Narasimha Minerals, subject to the following conditions.

- (i) Legal status of the diverted forest land shall remain unchanged;

- (i) The demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at the cost of User Agency and the safety zone area shall be demarcated properly;
- (ii) Compensatory afforestation over identified non-forest land over an extent of **4.53 ha** of non forest area in Sy No 269/269-1 at Balayyapalli (V)Seetharamapuram (M), SPSR Nellore District, shall be raised and maintained by the State Forest Department from funds to be provided by the User Agency;
- (ii) Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency;
- (iii) In case of the mining leases adjoining the habitation stretch of the boundary of the safety zone of the lease adjacent to the habitation/roads should be properly fenced by the user agency at the project cost to protect the vegetation/regeneration activities in the safety zone;
- (iv) The safety zone shall be maintained as green belt and to ensure dense canopy cover in the area, regeneration activity shall be taken up by the user agency at the project cost under the supervision of the State Forest Department;
- (v) No storage of magazines shall be done in the forest area;
- (vi) Mitigative measures plan for protection of forest located adjacent to the proposed quarry lease prepared by the Consultant Mining Geologist shall be carried out at the cost of the User Agency;
- (vii) The State Forest Department shall carry out afforestation and its maintenance on degraded forest land, identified in Compt No.457, Hazeepuram RF, Kanigiri Range measuring one and half times the area of forest land under safety zone at the project cost;

- (viii) The User agency through the State Forest Department shall undertake gap planting and soil & moisture conservation activities to restock and rejuvenate the degraded open forest (having crown density less than 0.4), if any, located in the area within 100 meters from outer perimeter of the mining lease;
- (ix) The User agency shall undertake mining in a phased manner and take due care for reclamation of the mined over area. reclamation activities are satisfactorily executed as per the mining plan to be approved by the competent authority
- (x) The user agency shall ensure stabilization of the overburden dumps by appropriate grading/ benching so as to ensure that that angles of repose at any given place is less than  $28^{\circ}$  ;
- (xi) The mining shall be done in the forest area in accordance with the mining plan to be obtained from the competent authority and mining area shall not be opened up haphazardly;
- (xii) Diversion of the said forest land under this approval shall be for a period co-terminus with the period of the mining lease proposed to be granted under the Mines and Minerals (Development and Regulation) amendment Act, 2015, or Rules framed there under;
- (xiii) As the UA submitted mining plan for a period of 5 years, the UA shall submit mining plan for the period from 6<sup>th</sup> year of mining to the RO Chennai / sub-Office Vijayawada;
- (xiv) User agency shall obtain Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986;
- (xv) The consent of the State Pollution Control Board shall be obtained under the Air and Water Act before commencement of mining operations, and it shall be renewed annually;
- (xvi) No labour camps shall be established on the forest land. User agency shall provide firewood preferably alternate fuel to the labourers and the staff



working at the site so as to avoid any damage and pressure on the adjacent forest areas;

- (xvii) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- (xviii) The forest land shall not be used for any purpose other than that specified in the proposal and total forest area utilized for the project shall not exceed **4.23 ha (including safety zone area)**.
- (xix) The forest land proposed to be diverted shall under no circumstances be transferred or sublet to any other agency or Department or person without prior approval of the Central Government;
- (xx) A comprehensive monitoring shall be done at the end of five years to study the impact of mining. If it is found that the lessee has violated or is not complying with the stipulated conditions, then the approval given under the Forest (Conservation) Act, 1980 shall be revoked;
- (xxi) The User Agency shall submit the annual self-compliance report in respect of the above conditions to the Regional Office Chennai / Sub Office Vijayawada and to the State Government;
- (iii) The User Agency and the State Government shall ensure compliance to provisions of all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project;
- (iv) Any other conditions that the Central Government may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency;
- (v) Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as prescribed under the Act, Rules and Guidelines relevant.
