सन्दर्भ: शासन सचिव का पत्र क्रमांक प.1(75)वन/2021 दिनांक 01.10.2023.

महोदय,

उपरोक्त विषयक शासन सचिव, वन विभाग, राजस्थान सरकार, जयपुर के पत्रांक प.1(75)वन/2021 दिनांक 12.07.2022 एवं समसंख्यक पत्र दिनांक 14.02.2023 का आशय ग्रहण करने का कष्ट करें जिसके माध्यम से राज्य सरकार द्वारा विषयांकित प्रस्ताव पर केन्द्र सरकार से वन (संरक्षण) अधिनियम, 1980 की धारा (2) के तहत स्वीकृति मांगी गयी थी।


प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 20.02.2023 द्वारा सैद्धांतिक स्वीकृति प्रदान की गई थी जिसकी अनुपालना उपरोक्त संदर्भित पत्र द्वारा प्रेषित की गयी है। प्रस्तुत अनुपालना के अवलोकन पश्चात्, केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 0.60 हे0 वनभूमि के प्रत्यावर्तन एवं 26 वृक्षों के पातन की विधिवत् स्वीकृति (Final/ Stage-II Approval) निम्नलिखित शर्तों पर प्रदान करती है:-

1. Legal status of the forest land shall remain unchanged.
2. Forest land will be handed over only after required non-forest land for the project is handed over by the user agency.
3. Compensatory afforestation shall be taken up by the Forest Department over 3.25 ha de-graded forest land, Survey No. 925 & 926 (Old Khasra No. 528), Village- Nechhawa, Tehsil & Range- Laxmangarh, District- Sikar, Rajasthan at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and mono-culture of any species may be avoided.
4. User agency shall restrict the felling of trees to 26 trees/minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
5. The trees with bird nests, reptiles and habitat of Wildlife was observed than such tree shall be treated with special care for relocation in the forest land by Forest Department at the cost of User Agency.
6. Boundary wall of 6 (six) feet height will be constructed along the boundary near habitation to protect forest land from encroachments at

the cost of User Agency.

7. No construction of Residential Buildings will be carried out on forest land.
8. After construction of boundary wall the remaining Nechhwa Forest Block shall be properly surveyed and demarcated and the encroachment if any has to be removed.
9. There are multiple roads seen in forest block, these roads should be closed except single road for use.
10. The layout plan of the proposal shall not be changed without prior approval of Central Government.
11. No labour camp shall be established on the forest land.
12. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
13. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
14. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
15. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the User Agency or the project life, whichever is less.
16. The forest land shall not be used for any purpose other than that specified in the project proposal.
17. The User Agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
18. All the conditions of Stage-I/ In-principle approval shall be strictly complied.
19. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
20. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
21. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
