Subject: Diversion of 44.52 ha of forest land in Vizianagaram for Development of Economic Corridors, Inter Corridors and feeder routes and coastal road primarily to improve the efficiency of freight movement in India (Lot-3/ Odisha & Jharkhand / Package-2) Raipur-Visakhapatnam in the State of Andhra Pradesh under Bharatmala Pariyojana in favour of Project Director, NHAI, PIU, Vizianagaram-reg

Sir,

Please refer to the State Government letter No. 178/Section.II/2022(1629500) dated 08.02.2022 and online proposal No. FP/AP/ROAD/151048/2022 seeking prior approval of the Government of India in accordance with Section'2' of Forest (Conservation) Act, 1980 for the above-mentioned project. The project was accorded in-principle approval (Stage-I) by the Central Government vide letter dated 30.03.2022. The State Government have reported compliance vide letter dated 23.08.2022 (received on 25.10.2022) to the conditions stipulated in the in-principle approval;

After careful consideration of the compliance report submitted by the State Government and importance of the project, I am to convey the Central Government's approval (*Stage-II*) under Section '2' of Forest (Conservation) Act, 1980 for diversion of **44.52 ha** of forest land in Vizianagaram for Development of Economic Corridors, Inter Corridors and feeder routes and coastal road primarily to improve the efficiency of freight movement in India (Lot-3/ Odisha & Jharkhand / Package-2) Raipur-Visakhapatnam in the State of Andhra Pradesh under Bharatmala Pariyojana in favour of Project Director, NHAI, PIU, Vizianagaram, subject to the following conditions:-

(i) Legal status of the diverted forest land shall remain unchanged;

- (ii) Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at the cost of the User Agency. Certain patches of the forest area proposed for diversion is abutting to non-forest area. Hence, the State Forest Department shall ensure demarcation of forest area to be diverted properly to avoid encroachments;
- (iii) The State Forest Department shall carry out compensatory afforestation in identified degraded forest land over an extent of 90.22 ha in the below mentioned compartments, from the amount which has already been realized from the User Agency;

- (iv) The State Forest Department shall ensure required number of plants to be raised in the degraded forest area as per the MoEF&CC guidelines & keeping in view prescriptions in the working plan and may include activities like fencing, if required in the CA scheme to avoid biotic pressure;
- (v) The State Forest Department shall demarcate CA land suitably for the purpose of identification of the plots for future monitoring purpose by the IRO, Vijayawada and the State Forest Department shall ensure regular monitoring of the CA planation to achieve successful plantation;
- (vi) Degraded forest land identified for CA purpose and CA scheme shall not be changed without prior approval of the Central Government;
- (vii) Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency;

- (viii) Wildlife Mitigation plan approved by the Chief Wildlife Warden shall be implemented by the State Forest Department from the amount which has already been realized from the User Agency. Detailed report on implementation of Wildlife Mitigation plan shall be informed to the IRO Vijayawada regularly along with the supporting documents;
- (ix) The User Agency shall raise and maintain avenue plantation on both sides of the road in consultation with DFO concerned;
- (x) The User Agency shall construct retaining walls and check walls wherever required, by consulting the DFO concerned, at the project cost;
- (xi) Construction of culverts / bridges, if any, over the natural streams/rivers/canals shall be done in such a manner that it does not hamper the natural course of water, does not give rise to water-logging, and also does not hamper movement of wild animals;
- (xii) Roadside cuttings and fillings which require engineering support shall be provided as per the instructions of the DFO concerned so as to stabilize the soil;

(xiii) Tree felling shall be carried out wherever necessary under strict supervision of DFO concerned and the UA may carryout translocation of trees wherever feasible at the project cost;

- (xiv) The dug out material / overburden shall be dumped outside the forest area. Storage of any material shall not be done in the forest area;
- (xv) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- (xvi) The User Agency shall provide fire wood preferably alternate fuel to labourers working at the site to avoid damage/tree felling and no labour camp shall be established inside the forest area;
- (xvii) Disturbance shall be kept minimum by creating labour camps outside the forest area as far as possible and it shall be the responsibility of the User Agency to ensure that the labourers & staff engaged in execution of work do not destruct nearby forest flora & fauna;

- (xviii) The total forest area utilized for the project shall not exceed <u>44.52 ha</u> and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal;
- (xix) The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, department or person without prior approval of the Central Government;
- (xx) The User Agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project;
- (xxi) Any other conditions that the Central Government or Regional Officer (Central) of Integrated Regional Office, Vijayawada may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the User Agency;
- (xxii) In the event of failure to comply with any of the above conditions the User Agency is liable for penal action as per the rules / guidelines issued under FCA, 1980;
