विषय: मेसर्स टोरन्ट गैस प्राईवेट लि० लखनऊ द्वारा जनपद बाराबंकी के अन्तर्गत सुल्तानपुर-लखनऊ मार्ग एन०एच०-731 (पुराना एन०एच०-56) के किमी० 167-168 (चैनेज 167.216) के मध्य बांयी पटरी (लखनऊ-सुल्तानपुर मार्ग के दांयी पटरी) पर ग्राम चौबीसी तहसील हैदरगढ़ जनपद बाराबंकी खसरा गाटा सं०-1888 एवं 1889 में प्रस्तावित सी०एन०जी० स्टेशन के स्थल से मुख्य मार्ग तक आवागमन में प्रभावित 0.221392 हे० (Entry Area = 0.0474419 ha. + Exit Area = 0.0777621 ha. + Separator island = 0.0961875 ha., Total area is 0.221392 ha.) संरक्षित वनभूमि के बिना वृक्ष पातन के गैरवानिकी प्रयोग की अनुमति के सम्बन्ध में।

महोदय,

कृपया उपरोक्त विषयक सचिव (वन), उत्तर प्रदेश शासन के पत्रांक पी-208/81-2-2022-800(231)/2022, दिनांक 15.07.2022 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रस्ताव पर वन (संरक्षण) अधिनियम, 1980 की धारा (2) के अन्तर्गत भारत सरकार की स्वीकृति मांगी है।

प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 23.06.2023 द्वारा कतिपय शर्तों के साथ सैद्धांतिक स्वीकृति प्रदान की गयी थी, जिसकी अनुपालना उपरोक्त संदर्भित पत्र के माध्यम से प्रेषित की गई है। प्रस्तुत अनुपालना के परीक्षणोपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार मेसर्स टोरन्ट गैस प्राईवेट लि० लखनऊ द्वारा जनपद बाराबंकी के अन्तर्गत सुल्तानपुर-लखनऊ मार्ग एन०एच०-731 (पुराना एन०एच०-56) के किमी० 167-168 (चैनेज 167.216) के मध्य बांयी पटरी (लखनऊ-सुल्तानपुर मार्ग के दांयी पटरी) पर ग्राम चौबीसी तहसील हैदरगढ़ जनपद बाराबंकी खसरा गाटा सं०-1888 एवं 1889 में प्रस्तावित सी०एन०जी० स्टेशन के स्थल से मुख्य मार्ग तक आवागमन में प्रभावित 0.221392 हे० (Entry Area = 0.0474419 ha. + Exit Area = 0.0777621 ha. + Separator island = 0.0961875 ha., Total area is 0.221392 ha.) संरक्षित वनभूमि के बिना वृक्ष पातन के गैरवानिकी प्रयोग की विधिवत् स्वीकृति निम्नलिखित शर्तों के साथ प्रदान करती है:-

1. Legal status of the forest land shall remain unchanged.
2. Compensatory afforestation shall be taken up by the Forest Department for plantation of 443 trees on area of 0.442784 ha in Shivnam Forest Block, Haidargarh Range, District Barabanki at the cost of the User Agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.
3. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
4. The layout plan of the proposal shall not be changed without prior approval of Central Government.
5. No labour camp shall be established on the forest land.
6. The Penalty for violation shall be equal to five times NPV of forest land per hectare plus 12 percent simple interest till the deposit is made.
7. Penal NPV to be imposed & collected as per the FCA guidelines dated 29-01-2018 and deposited to CAMPA fund.

8. Separator island has to be maintained as Green Belt, in consultation with DFO. Green belt plan on separator island shall be approved by DFO, ensuring appropriate site specific species. Green belt plan shall also include species to be planted on the periphery of retail outlets and service road, if applicable. Green plan in respect of Separator island/entry & exit /service road as applicable and duly approved by DFO be submitted along with compliance report.
9. Annual Compliance report regarding maintenance of Green belt on separator island along with geo tagged photographs as per approved green plan to be submitted through DFO to Nodal officer and Regional Office, MoEFCC.
10. Entire periphery of the establishment should be lined up with tree plantation at a close spacing of 1.0 to 1.5 meter keeping an offset of 1.5 meter from the boundary, with light crown trees which will maintain greenery without compromising with the land requirement of the establishment.
11. User Agency shall submit green plan to be implemented at the cost of user agency, duly approved by DFO, incorporating species details and existing trees which can be retained to ensure minimum number of trees to be felled. Green Plan should include plantation details along entry, exit, separator island as applicable. User agency shall maintain geo tagged photographs of planted trees. Six monthly geo tagged photographs of plantations be maintained and report be submitted to DFO and also available at site of retail outlet for inspection. Any mortality of trees be replaced by new plant."
12. User Agency and authorized signatory oil company issuing sanction letter shall be liable for land use including tree plantation for entry/exit and Separator island strictly as per the approved layout plan and any violation /non adherence shall attract penal action/prosecution in competent court of jurisdiction as per FCA(1980), Rules and guidelines.
13. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
14. The separator island will be provided in front of Fuel Station between acceleration and deceleration lanes and the space shall be used for plantation and its boundary shall be demarcated by a 2 ft. wall.
15. Plantation shall also be done along the inside boundary of CNG Station.
16. Greenery will be maintained by the user agency around the periphery of Retail outlet.
17. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
18. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
19. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
20. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
21. The forest land shall not be used for any purpose other than that specified in the project proposal.
22. The KML file of the area to be diverted, the CA areas, the proposed SMC work, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before commencement of works.
- 23. Annual 3rd party monitoring and concurrent internal monitoring by State Forest Department shall be done and monitoring reports submitted to this office.**
24. The User Agency and the State Government shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
25. Project Completion Report and Stage-II compliance report shall be submitted within a period of 6 months of completion of project.
26. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt. 29/01/2018.

27. The violation of any of the conditions stipulated under this approval will be liable to the cognizance and appropriate action under MoEFCC rules and Guidelines as applicable, specifically MoEFCC Guidelines dated 15/05/2023, authorizing officers of the rank of Divisional Forest Officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or Union territory Administration concerned, having jurisdiction over the forest land in respect of which any offence under the Forest (Conservation) Act, 1980 is committed or violation of the provisions of the said Act has been made, to file complaints against such person/authority/organization, prima-facie found guilty of offence under the Act or the violation of the rules made thereunder, in the court having jurisdiction in the matter.
28. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
