**विषय: Diversion of 6.75 ha forest land in favour of Public Works Department, Udaipur, Rajasthan for widening and strengthening of SH-32A from jhameshwarji to jagat road Km Stone No. 67/0 to 80/0 Tehsil- Girwa, District- Udaipur of Rajasthan.**

सन्दर्भ: शासन सचिव, वन विभाग, राजस्थान सरकार, जयपुर का पत्रांक प.1(23)वन/2023 दिनांक 13.11.2025.

महोदय,

उपरोक्त विषयक शासन सचिव, वन विभाग, राजस्थान सरकार, जयपुर के पत्रांक प.1(23)वन/2023 दिनांक 27.04.2023 का आशय ग्रहण करने का कष्ट करें जिसके माध्यम से राज्य सरकार द्वारा विषयांकित प्रस्ताव पर केन्द्र सरकार से वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा (2) के तहत स्वीकृति मांगी गयी थी।

प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 30.08.2023 द्वारा सैद्धांतिक स्वीकृति प्रदान की गई थी जिसकी अनुपालना उपरोक्त संदर्भित पत्र द्वारा प्रेषित की गयी है। प्रस्तुत अनुपालना के अवलोकन पश्चात्, केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 6.75 हे० वनभूमि के प्रत्यावर्तन एवं 106 वृक्षों के पातन की विधिवत् स्वीकृति (Final/ Stage-II Approval) निम्नलिखित शर्तों पर प्रदान करती है:-

1. Legal status of the forest land shall remain unchanged.
2. Forest land will be handed over only after required non-forest land for the project is handed over by the user agency.
3. Compensatory afforestation shall be taken up by the Forest Department over (i) 6.75 ha non-forest land, Khasra No. 1217, Village- Mamadev, Tehsil- Girwa, District- Udaipur and (ii) 20.00 ha degraded forest land, Forest Block- Kabri, Village- Jodhpuriya, Tehsil- Kurabad, District- Udaipur of Rajasthan at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
4. The State Government will ensure complete compliance of FRA, 2006 before issuance of final order for diversion.
5. The KML files of diverted area and CA area are to be uploaded on the e.Green Watch Portal before issuing the orders for diversion by the State Government.
6. User Agency shall restrict the felling of trees to 106 /minimum numbers in the

diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and cost of felling of trees shall be deposited by the User Agency with the State Forest Department.

7. **The User Agency shall construct 6 feet high wall along the boundary of the NFL provided for CA and proper fencing should be done along the boundary of the DFL CA patch.**
8. **The User Agency shall provide at its cost required number of Solar Pumps as given by the Forest Department for irrigating the CA plantation.**
9. The User Agency shall raise strip plantation on both sides and central verge of the road as per the IRC norms.
10. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas.
11. The trees with bird nests, reptiles and habitat of Wildlife was observed than such tree shall be treated with special care for relocation in the forest land by Forest Department at the cost of User Agency.
12. The layout plan of the proposal shall not be changed without prior approval of Central Government.
13. No labour camp shall be established on the forest land.
14. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
15. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer. The forest land diverted shall not be handed over to the user agency till the demarcation is completed on the ground.
16. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
17. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the User Agency or the project life, whichever is less.
18. The forest land shall not be used for any purpose other than that specified in the project proposal.
19. The User Agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
20. All the conditions of Stage-I/ In-principle approval shall be strictly complied.
21. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
22. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as prescribed in the Act/ Rules/ Guidelines in case of violation.
23. The User Agency shall provide CA in NFL area for compensatory afforestation in lieu of the forest area diverted, if applicable, based on the final outcome in the WP No.1164/2023, which is currently pending before the Hon'ble Supreme Court of India. The State Forest Department shall ensure

that an undertaking from the user agency is obtained in this regard.

24. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
