**Subject: Proposal for diversion of 22.51 ha i.e. 3.21 ha of fresh forest land in Panyam RF, Compartment no.145 (Bit-1&2) of Bugganapalli Beat, Compartment no.147 (Bit-3,4 & 5) and Compartment no.137 & 148 (Bit-6 & 7) of Konided Beat, Panyam Section, Kurnool Range, Kurnool Division and re-diversion of the 19.30 ha of forest area in Compt.No.145, 147 & 148 of Panyam RF, Konided Beat, Panyam Range, Kurnool Division (presently in Nandyal Division) for construction of new double line and electrification of track between Guntur and Guntakal Stations at Panyam (Rly Km.275-281 & km 285-288) between Dhone and Nandyal Stations in favour of Deputy Chief Engineer, Construction, Guntakal Division, South Central Railway, Guntakal - Reg**

Sir,

Please refer to the State Government's letter No 1075/Section. II/2023/(2094001) dated 02.6.2023, and online application No. FP/AP/RAIL/154617/2022 seeking prior approval of the Government of India for diversion of forest land in accordance with Section'2' of Forest (Conservation) Act, 1980 for the above-mentioned project. After careful consideration of the proposal and with the recommendation of the Regional Empowered Committee (REC), the in-principle (Stage-I) has been accorded vide letter of even no. dated 26.06.2023. The State Government has furnished compliance report on the conditions stipulated in the in-principle approval vide letter dated 21.07.2025 and complete EDS reply on 09.12.2025.

After careful consideration of the compliance report submitted by the State

Government, I am directed to convey the Central Government's **Formal Approval (Stage-II)** under Section '2' of Forest (Conservation) Act, 1980 for diversion of **22.51 ha i.e. 3.21 ha** of fresh forest land in Panyam RF, Compartment no.145 (Bit-1 & 2) of Bugganapalli Beat, Compartment no.147 (Bit-3, 4 & 5) and Compartment no.137 & 148 (Bit-6 & 7) of Konided Beat, Panyam Section, Kurnool Range, Kurnool Division and re-diversion of the 19.30 ha forest area in Compartment No.145, 147 & 148 of Panyam RF, Konided Beat, Panyam Range, Kurnool Division (presently in Nandyal Division) for construction of new double line and electrification of track between Guntur and Guntakal Stations at Panyam (Rly Km. 275-281 & km 285-288) between Dhone and Nandyal Stations in favour of the Deputy Chief Engineer, Construction, Guntakal Division, South Central Railway, Guntakal, subject to the following conditions:-

1. The legal status of forest land shall remain unchanged;
2. The State Forest Department shall raise and maintain plantation in degraded forest land identified over an extent of 6.42 Ha out of 10.02 ha has been identified in Compartment no.100 & 101, Gani RF from the funds to be provided by the User Agency;
3. The approved CA land and compensatory afforestation scheme shall not be changed without prior approval of the Central Government;
4. Considering the presence of fauna like Spotted deer etc the User Agency shall construct underpass/culverts at appropriate places (based on the usual route/crossing places and other such places wherever required) and dimensions of such underpass/culverts shall be dependent on nature of fauna existing in and around forest area proposed for diversion;
5. All other mitigation measures required as per the Wildlife Institute of India (WII) prescribed for such linear projects shall be implemented, if necessary, at the cost of the User Agency;
6. Tree felling shall be carried out wherever necessary under the strict supervision of the DFO concerned;
7. While execution of the project, earth cutting involving excavation of huge quantity of materials, hence proper disposal plan to dispose such excavated material shall be implemented in consultation with the DFOs concerned and the UA shall not take soil from the nearby the forest areas for execution of the project and no additional path / road shall be made to execute the project;
8. Proper SMC plan shall be implemented to check soil erosion, at the project cost;
9. Proper labour camps shall be constructed in the non-forest area and in any case, labour camp shall not be made within the RF area;
10. The DFOs shall monitor the project site regularly and submit such monitoring reports to the SO Vijayawada so as to take remedial measures, if required;
11. Speed regulating signage will be erected along the railway line at regular intervals in the Protected Areas/ Forest Areas;
12. The layout plan of the proposal shall not be changed without prior approval of the Central Government;
13. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourers after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
14. No additional or new path will be constructed inside the forest area for the transportation of construction materials for execution of the project work;
15. The forest land shall not be used for any purpose other than that specified in the project proposal;
16. The forest land proposed to be diverted shall under no circumstances be transferred or sublet to any other agencies, department or person without prior approval of Govt. of India;

17. Pre-fabricated structures should be used to the maximum possible extent to reduce the extent of disturbance in the habitat;
18. The total forest area utilized for the project shall not exceed **3.21 ha** and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal. The User Agency shall furnish an undertaking to this effect;
19. The User Agency and the State Government shall ensure compliance to the all acts, rules, regulation and guidelines of the Ministry, for the time being in force, as applicable to the railway line projects;
20. Any other conditions that the Ministry of Environment, Forests & Climate Change Regional Office, Chennai/Sub Office, Vijayawada (Central) may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the User Agency;
21. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as prescribed in para 1.16 of Chapter 1 of the Handbook of Comprehensive Guidelines of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 as issued by this Ministry's letter dated 29.12.2023.
22. The State Government, before issuing the final diversion order, shall ensure that the user agency has complied with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s), including compliance of Forest Rights Act, 2006, pertaining to this project, for the time being in force, as applicable to the project; and
23. The User Agency shall submit the annual self-compliance report in respect of the above stated conditions to the State Government, concerned Regional Office, Chennai/Sub Office, Vijayawada (Central) by the end of March every year regularly.
24. The User Agency has made payment Rs. 3,51,65,561/- towards CA and NPV (Rs. 75,10,000/- towards CA and Rs.2,76,55,561/- towards NPV ). The levies paid by the UA shall be utilized for the same as per the approved plan/scheme.
