Madam,

With reference to the subject and reference cited above, this is to inform that the subject proposal submitted by the State Government has been examined. The satellite imagery reveals availability of alternatives and the access through other katcha roads. It also reveals the existence of a road for which supporting documents for the pre-existence of the cart track through the forest area and usage by the villagers as claimed or any permissions given, have not been submitted.

Further, giving exclusive access to one single applicant over a road would lead to right of way complications and fait accompli situations of other downstream entities. The State Government may therefore review the entire issue and deal with the access provisions comprehensively including the one proposed in the instant proposal. I am therefore directed to convey the rejection of the proposal.
