

Memorandum:-

With reference to letter no: (3) Social Forestry division, surat has given an "In Principle" approval for diversion of 0.2592 ha.of Protected Forest land for laying Optical Fiber Cable 4.655 KMS on SH-80 from Nizar toward vaka (2) 1.045 KMS on MD Road from vaka toward Nandurbar till Gujrat State Border Total Length 5.761 KMS Uchchhal Taluka parallel to Road side strip plantation declared as Protected Forest in Surat District in favour of "Vodafone Idea Limited " Vide letter dated 22/07/2016 referred above at (4).

The undersigned is pleased to convey the "formal approval" of the Government under section 2 of the Forest (Conservation) Act, 1980.subject to the following conditions :-

- 1 The permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- 2. The aforementioned project along the roads within existing right of way not falling in National Parks and wildlife sanctuaries, without felling of trees, where the Optical Fiber cable line will be laid underground with Maximum size of the trench is not more than 2.00 meter depth and 1.00 meter width subject to condition stipulated in the general approval accorded

by the ministry vide letter No 11-9/98-FC Dated 16th October,2000 as extended /amended from time to time.

- 3 The Forest land shall not be used for any purpose other than specified in the FCA Proposal.
- The User Agency will have to obtain permission from this office for carrying out any maintainance works in future.
- The User Agency will have to make good the forest land after use/maintainance work.No trees will be cut.
- 6. The User Agency will be liable to make good any loss to Forests / Environment caused due to the use of the said land by the user agency.
- The User Agency will seek permission from the Roads & Buildings Department / Science and Technology Department, Sachivalay, Gandhinagar.
- 8. Any other condition which the Nodal Office (FCA) may stipulate from time to time.
- 9. User Agency Has to Submit FRA Certificate.
