विषयगत प्रकरण में वन (संरक्षण एवं संवर्धन) अधिनियम 1980 सपिठत वन (संरक्षण एवं संवर्धन) नियम 2023 के अन्तर्गत जनपद हाथरस में मैसर्स हिन्दुस्तान पेट्रोलियम कार्पोरेशन लिमिटेड द्वारा सादाबाद—जलेसर मार्ग (एस०एच०—122) किमी० 49 के मध्य बॉयी पटरी पर खसरा संख्या—1096 ग्राम सहपऊ तहसील सादाबाद जनपद—हाथरस में स्थापित होने वाले रिटेल आउटलेट के सम्पर्क मार्ग के निर्माण हेतु प्रभावित 0.0781246 हे0 संरक्षित वन भूमि के गैर वानिकी प्रयोग एवं बिना वृक्ष पातन की अनुमित सम्बन्धी प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 19.02.2025 द्वारा निर्गत सैद्वान्तिक स्वीकृति (Stage-I) में उल्लिखित शर्तों की प्रेषित अनुपालन आख्या के क्रम में निम्नलिखित शर्तों / प्रतिबन्धों के अधीन एतद्द्ववारा विधिवत स्वीकृति (Final Sanction) निर्गत की जाती हैं:—

- 1 Legal status of the diverted forest land shall remain unchanged.
- Compensatory afforestation shall be taken up by the Forest Department for the plantation over an area of 0.1600 ha. or (160 plants) degraded forest land in Tatidandia van forest block, Sikandra rao Forest Range, Forest division, District- Hathras at the cost of the User Agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.
- The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- The Divisional Forest Officer shall charge the Net Present Value (NPV) for the 0.0781246 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5- 1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5- 3/2007-FC dated 05/02/2009 and 5-3/2011-FC (Vol-I) dated 06.01.2022 and 19-01-2022 shall be deposited by User Agency in this regard.
- Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

- The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 7 No violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 certificate from concerned DFO shall be provided.
- 8 Greenery will be maintained by user agency around Periphery of Fuel Station.
- 9 User agency shall use the land between entry and exit for plantation and conservation of trees, the same shall be demarcated by 2 feet wall.
- 10 Plantation shall also be done along the inside boundary of Fuel Station.
- 11 Certificate of DFO certifying that the proposed RO is not in close proximity of any existing RO in accordance with MORTH guidelines dated 24-07-2013 has to be provided.
- The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- The KML file of area proposed for diversion and area proposed for plantation shall be uploaded on the E-Green watch portal with all requisite details before commencement of works.
- Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/).
- Entire periphery of the establishment should be lined up with plantation at a close espacement of 1.0 to 1.5 meter keeping an offset of 1.5 meter from the boundary, with light crown tree species which will maintain greenery without compromising with the land requirement of the establishment.
- Separator island has to be maintained as Green Belt, in consultation with DFO. Green belt plan on separator island shall be approved by DFO, ensuring appropriate site specific species. Green belt plan shall also include species to be planted on the periphery of retail outlets and service road, if applicable. Green plan in respect of Separator island/entry & exit /service road as applicable and duly approved by DFO be submitted along with compliance report.
- User Agency and authorized signatory oil company issuing sanction letter shall be liable for land use including tree plantation for entry/exit and Separator island strictly as per the approved layout plan and any violation /non adherence shall attract penal action/prosecution in competent court of jurisdiction as per Van (Sanrakshan Evam Samvardhan) Adhiniyam (1980), Rules and guidelines.
- Violation of any of the conditions stipulated under this approval will be liable for cognizance and appropriate action under MoEFCC rules and Guidelines as applicable, specifically MoEFCC Guidelines dated 15/05/2023, authorizing officers of the rank of Divisional Forest Officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or Union territory Administration concerned, having jurisdiction over the forest land in respect of which any offence under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is committed or violation of the provisions of the said Adhiniyam has been made, to file complaints against such person/authority/organization, prima-facie found guilty of offence under the Adhiniyam or the violation of the rules made thereunder, in the court having jurisdiction in the matter.
- Green Plan duly approved by DFO in respect of Separator island/entry/exit/service road as applicable be submitted and Geo tagged six monthly reports be maintained at retail outlet and be submitted six monthly.
- The approval shall be revoked if any change in forest area/forest boundary occurs after Digitization of forest boundaries is completed.
