- (i) In-principle approval Letter No. 7-5/3-FD/606/52 dated 26<sup>th</sup> July, 2018 issued by the Chief Conservator of Forests / Nodal Officer, U.T. Administration of Dadra & Nagar Haveli, Silvassa

**ORDER**

In pursuance of the In-Principle approval given (1) above for Diversion of 0.91 Ha. Reserved Forest Land for Erection of 100 KVA Transformer Centre with 11 KV HT Line at Sindoni- Loharmal for release of domestic service connection in the U.T. of Dadra & Nagar Haveli, the User Agency (DNH Power Distribution Corporation Ltd.) has complied with all the conditions stipulated in the In-principle approval. The User Agency (DNH Power Distribution Corporation Ltd.) has deposited ₹ 19,19,605/- (Rupees: **Nineteen Lakh Nineteen Thousand Six Hundred Five only**) as per the demand note issued vide letter No. 7-5/3-FD/606/52 dated 26<sup>th</sup> July, 2018 towards Compensatory Afforestation and Net Present Value of the land along-with the compliance of the conditions (i) above.

The undersigned on behalf of the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu is hereby pleased to convey the "**Final / Stage - II approval**" to the User Agency (DNH Power Distribution Corporation Ltd.) to use 0.91 ha Reserved Forest land for Erection of 100 KVA Transformer Centre with 11 KV HT Line at Sindoni- Loharmal for release of domestic service connection in the Union Territory of Dadra & Nagar Haveli and Daman & Diu as indicated in the application and the map enclosed along-with application, subject to the following conditions :-

- i The legal status of the forest land shall remain unchanged i.e. shall remain Reserved / Protected / Village / other types of forests as the case may be.
- ii Project shall restrict the felling to trees 19 Nos. of trees in the diverted forest land. The trees shall be felled under strict supervision of the Forest Department and only trees shall be felled which are absolutely essential for project.
- iii The Erection of 100 KVA Transformer Centre with 11 KV HT Line shall be done as per the approved route designed.
- iv Compensatory afforestation shall be taken up by the Forest Department at the cost of the user agency and the same shall be maintained for 10 Years. Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the State Forest department.



- v The User agency shall seek permission from local Forest Department for carrying out any maintenance;
- vi All statutory provisions under various Acts, Rules there under and guidelines applicable to this project shall be strictly adhered to.
- vii The forest land shall not be used for any purpose other than that specified in the proposal.
- viii The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.

This issues with the approval of Competent Authority.
