Sub: Diversion of 0.01294 ha. of forest land for access to the proposal retail outlet of BPCL at Mustil No. 41, Killa No. 2/2 on Tauru-Bilaspur road at km. 61.725 LHS MDR132 in Municipal Limits at village Tauru Tehsil-Tauru, District Nuh, Haryana. FP/HR/Approach/152691/2022

Kindly refer to the subject cited above mentioned proposal, in which the permission of the State Govt. has been sought under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. In this regard, In- Principle approval was granted on dated 05/07/2024, whose compliance report was received from Divisional Forest Officer, Nuh-Mewat on dated 13/08/2024. In accordance with power delegated to Nodal Officer (FCA) by Govt. of Haryana vide order no.629-FT-1-2024/1749 dated 15/03/2024 for diversion cases less than 0.1 ha. "Final Approval" for the above-mentioned project is hereby granted subject to the following conditions:-

1. General Conditions

1. Legal status of the forest land shall remain unchanged.
2. The number of trees/plants to be felled shall not in any way exceed the number indicated in the proposal and no harm shall be done to the wildlife during felling of trees. The felling of trees/plants will be carried out under the strict supervision of the State Forest Department and the amount spent on felling of trees/plants will be deposited by the user agency to the State Forest Department.
3. As per the proposed CA Scheme, Compensatory afforestation (CA) shall be taken up by the State Forest Department over degraded forest land in **Ghata Shamshabad Sec. 4&5 Firozpur Jhirka Range Distt. Nuh-Mewat** by planting **100 plants** at the cost of the user agency. The Plantation shall be done within one year from the date of issue of approval. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species shall strictly be avoided.
4. The Divisional Forest Officer shall ensure that the approved CA site will not be changed without the approval of Competent Authority.
5. The State CAMPA Authority shall ensure that the funds under State CAMPA are released to Divisional Forest Officer as per approved CA scheme.
6. The Divisional Forest Officer shall upload the KML files of the degraded forest area accepted for raising compensatory afforestation in the E-Green watch portal of FSI, before handing over of forest land to the user agency.
7. The diverted forest land shall not be used for any purpose other than that specified in the proposal.

8. The user agency shall pay additional amount of NPV as and when increased by the order of MoEF&CC or any Court and Divisional Forest Officer will ensure that the increased amount is deposited.
 9. The initial permission is given to this proposal for 15 years. After that the permission shall again be obtained under the extant Rule under Van (Sanrakshan & Samvardhan) Adhiniyam,1980.
 10. No damage will be done to the adjoining forest land. Simultaneously, all efforts will be made to save adjoining forest and forest land.
 11. The forest land proposed to be diverted shall, under no circumstances, be transferred to any other agency, department, or person without approval of the Competent Authority under Van (Sanrakshan & Samvardhan) Adhiniyam,1980.
 12. The layout plan of the proposal shall not be changed without prior approval of Competent Authority under Van (Sanrakshan & Samvardhan) Adhiniyam,1980.
 13. The user agency shall carry out muck disposal at pre-designated sites as per the approved scheme.
 14. Any other condition may be stipulated by Divisional Forest Officer from time to time, in the interest of conservation, protection and development of forests & wildlife.
 15. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
 16. It will be the responsibility of the Divisional Forest Officer/User Agency to obtain all other prior approvals/clearances under all other relevant Acts/Rules/ Court's Rulings/instructions, etc., including environmental clearance, as applicable to this proposal.
 17. Violation of any of these conditions will amount to violation of Van (Sanrakshan & Samvardhan) Adhiniyam,1980 and action would be taken as per the guidelines issued by MoEF&CC.
 18. The Competent Authority may suspend/cancel this approval if the implementation of any of the above conditions is not satisfactory. The Divisional Forest Officer will ensure compliance of these conditions.

2. Specific Conditions:

1. Light Crown trees should be planted at an interval of 1.0 to 1.5 meters on the entire periphery of the petrol pump leaving 1.5 meters space from the wall.
 2. The user agency will also carry out plantation on the access road (Entry/Exit or Deceleration/Acceleration) and on the Separator Island. Further this separator island will not be used for any kind of commercial purpose.
