Sub:General approval – compliance report of stage –I granted for diversion of 0.0147 ha. of forest land in Survey No.114/1 of Gawali Wada Khandepar in Ponda Taluka, North Goa District and Division for work of laying 33 KV XLP underground cable double circuit from Ponda Substation to Opa Water Supply plant in favour of Executive Engineer, Electricity Department, W.D.III, Curti, Ponda, Goa reg....

Sir,

I am to invite your attention to letter No.6-881-2017-18/FD/082 dated 23/04/2018 wherein State Government had conveyed Stage-I (in principle) approval for diversion of 0.0147 ha. of forest land in Survey No.114/1 of Gawali Wada Khandepar in Ponda Taluka, North Goa District & Division for work of laying 33 KV XLP underground cable double circuit from Ponda Substation to Opa Water Supply plant in favour of Executive Engineer, Electricity Department, WD- III, Curti – Ponda - Goa, subject to certain conditions.

The Deputy Conservator of Forest, Monitoring & Evaluation, Forest Department, Government of Goa/Nodal Officer under Forest (Conservation) Act vide Note bearing No.6-881-2023-24-FD dated 12/07/2023 has reported the compliance submitted by the User agency to the conditions stipulated by the State Government in the in-principle approval under section 2 of the Forest (Conservation) Act, 1980 as delegated vide Para No.4.3.1 (General Approval) of the FCA, 1980 Handbook of the Ministry of Environment, Forest and Climate Change, Government of India, New Delhi, for the above project.

Upon careful examination of the compliance report of the proposal furnished by the Nodal Officer, FCA, I am directed to convey the State

Government's final approval (Stage –II) for the 0.0147 ha. of forest land in Survey No.114/1 of Gawali Wada Khandepar in Ponda Taluka, North Goa District & Division for work of laying 33 KV XLP underground cable double circuit from Ponda Substation to Opa Water Supply plant in favour of Executive Engineer, Electricity Department, WD- III, Curti – Ponda - Goa, subject to following conditions:-

- 1. The legal status of the diverted forest land shall remain unchanged.
- 2. The demarcation of the forest area to be diverted shall be carried out by erecting cement concrete pillars duly numbered at interval of 20 metres at the cost of user Agency.
- 3. The User Agency shall abide by all the conditions as per the guideline No.6-175/2017/WL dated 19/02/2018 of Ministry of Environment, Forest and Climate Change.
- 4. The User agency shall deposit, the Net Present Value (NPV) of diverted forest land admeasuring 0.0147 ha. as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 & 09/05/2008 in IA No.566 with related IA's in Writ Petition (Civil) No.202/1995 and the guidelines issued by the Ministry vide letter No.5-3/2007-FC dated 05/02/2009 in this regard. Additional amount of Net Present Value (NPV) of the diverted forest land, if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future shall be charged by the State Government from the User Agency.
- 5. The total forest area to be utilised for the project shall not exceed 0.0147 ha.
- 6. The forest land shall not be used for any purpose other than that specified in the proposal.
- 7. Any other condition that the Principal Chief Conservator of Forests, Goa Forest Department, Government of Goa, may impose from time to time in the interest of conservation, protection or development of forest.
