ORDER

In pursuance of the In-Principle approval given above for Construction of approach road from Rudana Magarpada to Samsan in the U.T. of Dadra & Nagar Haveli and Daman & Diu, the User Agency (Executive Engineer, PWD Civil Division No. III (Irri.), D&NH, Silvassa) has complied with all the conditions stipulated in the In-principle approval. The User Agency (Executive Engineer, PWD Civil Division No. III (Irri.), D&NH, Silvassa) has deposited ₹ 3,35,473/- (Rupees: Three Lakh Thirty Five Thousand Four Hundred Seventy Three only) as per the demand note issued vide letter No. 7-5/3-FD/634/343 dated 13th February, 2025 towards Compensatory Afforestation and Net Present Value of the land. The undersigned on behalf of the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu is hereby pleased to issue the Stage - II clearance (Formal Order) to the User Agency (Executive Engineer, PWD Civil Division No. III (Irri.), D&NH, Silvassa) to use 0.066 hect. of Reserved Forests land for Construction of approach road from Rudana Maragpada to Samsan in the Union Territory of Dadra & Nagar Haveli and Daman & Diu as indicated in the application and the map enclosed along-with application, subject to the following conditions :-

- i The legal status of the forest land shall remain unchanged i.e. shall remain Reserve / Protected / Village / other types of forests / forest as the case may be.
- ii No felling of trees shall be involved in the implementation of the proposal.
- iii Compensatory afforestation shall be taken up by the Forest Department at the cost of the user agency and the same shall be maintained for 10 Years. Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the State Forest department.
- iv Additional amount of the NPV of the diverted forest land if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

- v The User agency shall seek permission from local Forest Department for carrying out any maintenance;
- vi All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.
- vii The forest land shall not be used for any purpose other than that specified in the proposal.
- viii The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.
- ix Proposed labour camps outside the forest area to be dismantled and removed. The labourers shall be sent back immediately after the completion of work.
