Memorandum:-


This office has given an "In Principle" approval for diversion of 0.1035 ha of forest land for laying of Optical Fibar Cable along the Road in Village Shihor, Survey No. 272 Pt Taluka: Shihor District Bhavnagar for laying OFC vide this office letter Dated 24/12/2018 ref. above at (3)

The Authorised Signatory of Rail Tail Corporation of India Ltd. has Submitted a compliance report with necessary documents.(Ref.-4)

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act,1980, subject to the following conditions:-

1. The permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of forest land shall remain unchanged.
2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
3. The User Agency will have to obtain permission from this office for carrying out any maintenance works in future.

4. The User Agency will have make good the forest land after use/ maintenance work. No tree shall be cut.
5. The User Agency will be liable to make good any loss of Forests/Environment caused due to the use of the said land by the user agency.
6. The User Agency will seek permission from the Roads& Building Department/Science and Technology Department, Sachivalaya, Gandhinagar.
7. The Optical Fiber Cable.line will be laid underground in a trench of depth of 1.65 Mtr and width of 0.45 Mtr.in between rows of road side plantation.
8. Any other condition, which the Nodal Officer (FCA) may stipulate from time to time.
