This Office has given "In principle" approval for division of 0.0540. ha.Of reserve forest land for laying of Optical Fiber Cable in Ta.Babra Village-Kotadapith Survey no.386 P.B,for laying Optical Fiber Cable along the routs. vide this office letter dated.04/02/2022. referred above at (9).

The RailTel Corporation of India Limited registration Fees,Processing fees & N.P.V.is exemption vide Additional Principal Chief Conservator Of Forest(Land),Gujarat State Gandhinagar Latter No.FCA/29/A/1062-1135 Dt:10/03/2016 so registration Fees, Processing fees & N.P.V.is not applicable for this proposals.

The undersigned is pleased to convey the formal approval of the Government under section-2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

- This permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
- The Forest land shall not be used for any purpose other than that specified in the FCA proposal. The user agency will have to obtain permission from the under signed for carrying out any maintenance works in future.
- The user agency will have to make good the forest land after use/ maintenance works. no tree shall be cut.
- The user agency will be liable to make good any loss to Forest / Enviroment caused due to the use of the said Land by the user agency.
- The user agency will seek permission from forest department/Science and Technology department, Sachivalay Gandhinagar.
- The line will be laid underground in a trench of the depth not more then of 2.00 meter & width not more then of 1.00 meter in Forest area.
- Any other condition with the Nodal officer (FCA) the state Government may stipulate from time to time.
