Site Inspection Report Proposal NO. FP/JH/Min/790/2008

The extant FC Proposal No. FP/JH/Min/790/2008 pertains to proposed diversion of 247.5 Ha of Forest land in Saranda Forest Division (West Singhbhoom District of Jharkhand) in favour of M/s Steel Authority of India Limited (SAIL) for Iron Ore Mining in Kiruburu-Meghahatuburu group of Iron Ore mines within its total lease area of 2897.499 Ha.

The Proposal has been accorded in-principle approval on 18.10.2010. Condition No. 22 of this in-principle approval required the user agency to surrender equal extent of forest area duly reclaimed and afforested from the already diverted area.

The proposal was again discussed in the FAC meeting and the committee desired IRO Ranchi to revisit the site to resolve the following queries of the committee: -

- (i) Detail of permanent structures observed in the mining leases of the user agency in relation with violation of provisions of FC Act 1980, if any, committed in the construction of said structures.
- (ii) Status of change in the scope of the project, if any, affected by the user agency during the lapse of a considerable period of almost 12 years from the date of grant of Stage-I approval on 18.10.2010. A factual situation of the ground reality may be documented and submitted to the ministry.
- (iii) As the considerable time has elapsed, the project affected trees may be remunerated and on abstract. Showing details of the project affected trees along with change in their number, needs to be furnished in consultation with State Forest Department. Moreover, suitability of CA land proposed over degraded forest land may also be verified by the IRO.
- (iv) Unambiguous information, with supporting details relating to the status of reclamation and land handed over back to the State Forest Department. IRO may furnish its clear recommendation on the claim of user agency to hand over 172.2 Ha of forest area after receiving the Stage-II approval after detailed analysis of the reclamation measures adopted by the user agency and technical and administrative constraints, if any, involved.
- (v) Any other information that IRO may deem relevant.

Accordingly, the team of IRO Ranchi comprising of its DDGF and AIGF revisited the CA area as well as proposed diversion area on 7th & 8th November 2022 to gather the required information. The findings of the site inspection, done in presence of user agency representatives, corresponding to the queries are presented as following: -

(i) SAIL has a total lease of 2897.499 Ha that comprises of three leases, lease-I of 1936.06Ha, lease –II of 879.439 Ha & Lease –III of 82 Ha area (all in forest). Lease-I is for Iron-ore mining whereas Lease areas of lease –II & III are for township & other allied mining activities. The component wise details of diverted areas till date are presented in the table below:

From the above table, it is evident that after 1980, only 37.90 ha area is broken out of which 29.2 Ha is for mining excavation and 8.7 Ha area is for storage of tailings. Photographs of Tailing pond area given below:



Therefore, the project proponents have reported that there is no construction of any permanent structure in the mining lease after 1980 in violation of Forest Conservation Act-1980.

- (ii) The proposal is for iron-ore mining in the forest area of 247.5 Ha. The proposal has received its in-principle approval on 18.10.2010. the user agency representatives present there apprised that the proposal still remains the same with singular motive of Iron-ore mining from the area under application. Hence the scope of the project has not witnessed any change and the objective of the forest diversion remains the same for which Stage-I approval was obtained.
- (iii) As per the instruction received by the FAC, the state forest department and the project proponent were requested to re-enumerate the trees that are thriving in the area. The details of the trees present today and that in 2014 are listed in the following table:

IRO Team visited the area and found that tree enumeration has been done recently.



Total compensatory afforestation (CA, DFL) stipulated against the proposal is 512 Ha which comprises in two forest division namely Gumla 61 ha. and Khunti 451 ha. Visiting IRO team inspected in the proposed CA area at Khunti Forest Division. The proposed CA area was examined by IRO in presence of State Forest Officials as well as representatives of User Agency. The entire area of 451 ha. in Khunti Forest Division consist of 8 different patches the detail of which is listed below:

Patched at serial no. 2 Sarjamdih area consisting of 87 Ha. was visited by IRO. The area is open and no significant vegetation was seen in the area. Similarly, the patch apparently was free from any kind of plantation impediments. The area is depicted in the following photographs.




In Gumla Forest Division the CA area was taken for advance work in the year of 2020-2021 CAMPA APO and was planted next monsoon. Therefore, CA area of the project situated in Gumla Forest Division is already planted. The Photographs of advanced action as well as planting towards the same are presented below:







(iv) Regarding status of reclamation and handing over land back to state forest department, user agency apprised that they have 78.3 ha. (51.4 ha+26.9ha) of land readily available with them to be handed over to State Forest Department for which they have already communicated to the concerned DFO. The copy of letter by User Agency to the DFO towards the request is attached herewith (Annexure-I). The 51.4 ha. area comprises of 41 ha. forest area apportioned for waste dump (reclaimed and rehabilitated by user agency) and 10.4 ha. mined out area which has been rehabilitated by user agency. The 26.9 ha. area has been identified by user agency from the diverted area where various infrastructure facilities were created since project inception. These identified areas are shown in following satellite imagery:



User agency further apprised the inspecting IRO team that once state-II for the proposal is obtained, the process of backfilling the existing mine pits may be taken up and the reclaimed and rehabilitated 172.2 ha. (existing pit area) land would be surrender to State Forest Department in progressive manner utilizing the overburden taken from newly broken areas. The handing over plan of 172.2 ha as prepared by user agency after the Stage-II approval is presented in following table:

Therefore, the entire existing mine pit would be surrendered completely by user agency to state forest department within 5 years from the receipt of Stage-II, although user agency intends to retain 9.2 ha. area from the above for supplementary logistic purpose. Hence, Out of 172.2 ha. of area where Iron Ore Mining is happening today, shall be completely rehabilitated and 163 ha. area of it shall be returned to forest department within 5 years since receipt of Stage-II approval in the extant case. Only 9.2 Ha. area would be used by user agency for access purpose.

Further, condition no. 22 of Stage-I for the proposal demands surrender of equal extent of area duly reclaimed and afforested from the already diverted forest areas. As explained by IRO in its earlier Site Inspection report submitted to Ministry on 27.05.2022, the matching area of 247.5 ha. practically cannot be reclaimed and surrender as mining is happening in 172.2 ha. only. User agency informed that 247.5 ha. area can be surrendered from already diverted area only if new areas are broken for mining. User agency has already prepared a plan to surrender completely rehabilitated 247.5 ha. land within 5 years from the grant of stage-II. The entire plan is shown in the following table:

**16.6 ha. area has been identified by user agency from there Township that pertains to area where redundant and obsolete buildings are lying (area requires around the 5 years' time for complete rehabilitation after the removal of these old buildings and debris).

(v) User agency has 2897.499 ha. of entire lease area (all in forest) comprising in three different leases of 1936.06 ha., 879.439 ha. and 82 ha. respectively. Till date 726.09 ha. areas is diverted and 247.5 ha. area is under application for diversion in extant case. Rest more than 1800 ha. area within the lease is undisturbed and under possession of user agency. Representative of user agency emphasized that if the matching area needs to be surrendered before issuance of S-II, it can be taken from this undisturbed area.

IRO team further solicited the possibility of surrendering the backfilled area to forest department which can be planted, rehabilitated and maintained by forest department at the cost of user agency. If, such a mechanism is developed, it will reduce the required time for complete surrender on one hand and will ensure better rehabilitation under care and expertise of State Forest Department on the other.

Hence the point-wise information as solicited by the FAC after revisiting the area is hereby being presented by IRO Ranchi for further consideration of the proposal.

Kiriburu Iron Ore Mine (KIOM) and Meghahatuburu Iron Ore Mine (MIOM) were developed in a mining lease (Lease-I-1936.06 ha). Contagious to the Lease-I, there are two non-mineralized leases namely Lease-II (879.439 ha) & Lease -III (82 ha). Government of Jharkhand vide order dated-30/07/2019 amalgamated these three leases covering total area of 2897.499 ha and extended the lease period up to 27/03/2030.

The existing mining and associated activities of both Kiriburu- Meghahatuburu Mines are covered under broken area of 726.09 ha (644.26 ha in Lease-I, 55.90 Ha in Lease-II & 25.93 ha in Lease-II) for which stage-II FC has been granted.

In compliance to the Condition No-22 of Stage-I FC relating to Surrender of equal extent of area duly reclaimed and afforested from the already diverted forest area, Progressive Reclamation & Rehabilitation of mined out areas and waste dumps are being done as per the approved mining plans to the feasible extent. Till date, we have submitted request for surrender of 51.40 Ha from the Mined Out and Waste dump area vide letter no- 4347 dated – 18/05/2022

In addition to that, 26.90 Ha area from Both Sides of Electric Line & Road from south block to tailing dam is also fully reclaimed & rehabilitated and ready to handover to the State Forest Department.

We would therefore request you to kindly take necessary action towards handing over the additional 26.90 ha reclaimed & rehabilitated area from already diverted area (Both Sides of Electric Line & Road from South Block to Tailing Dam) from the amalgamated lease hold area of Kiriburu-Meghahatuburu Iron Ore Mines, SAIL

Kiriburu Iron Ore Mine (KIOM) and Meghahatuburu Iron Ore Mine (MIOM) were developed in a mining lease (Lease-I : 1936.06 ha). Contiguous to the Lease-I, there are other two non-mineralized leases namely Lease-II (879.439 ha) & Lease-III (82 ha). Government of Jharkhand vide order dated 30/07/2019 amalgamated these three leases covering total area of 2897.499 ha and extended the lease period up to 27/03/2030.

The existing mining and associated activities of both Kiriburu and Meghahatuburu Mines are covered under diverted area of 726.09 ha (644.26 ha in Lease-I, 55.90 ha in Lease-II & 25.93 ha in Lease-III) for which Stage-II FC has been granted.

The Condition No.-22 of Stage-I FC order dated 18/10/2010 for 247.50 ha under the amalgamated lease of Kiriburu- Meghahatuburu Iron Ore Mines states to surrender equal extent of area duly reclaimed and afforested from the already diverted forest area. In compliance to this condition, the progressive reclamation & rehabilitation of mined out areas and waste dumps are being done as per the approved mining plans to the feasible extent. Till now, 10.40 ha Mined Out area has been fully reclaimed and rehabilitated through backfilling and plantation and 41 ha Waste Dump area has also been reclaimed & stabilized through plantation. Therefore, total 51.40 ha (41 ha Waste Dump + 10.40 ha Mined Out) is fully reclaimed & rehabilitated and is ready to be handed over to the State Forest Department. The plan showing 51.40 Ha reclaimed & rehabilitated area and phasewise Reclamation & Rehabilitation plan is enclosed.

We would therefore request you to kindly do needful for taking over the 51.40 ha area duly reclaimed & rehabilitated from already diverted forest area from the amalgamated lease of Kiriburu-Meghahatuburu Iron Ore Mines, BSL, SAIL
