B. Wildlife: Whether forest area proposed for diversion is important from wildlife point of view or not: Yes. The compartments mentioned in the locations are covered in TCP of Tadoba Andhari Tiger Reserve, Maharashtra. The User Agency has moved for SCNBWL's approval.

C. Vegetation:

i. Details of total number of trees to be felled:

Total Trees enumerated = 113425.

All trees are proposed to be felled except those located in the safety zone. Number of trees present in the safety zone is not known/not specifically enumerated.

ii. Effect of removal of trees on the general ecosystem in the area: There will be a significant impact of the removal of trees from the area on the ecosystem, especially a tiger habitat. The dominant trees species are-*Anogeissus latifolia, Tectona grandis, Chloroxylon swietenia, Diospyos melanoxylon* and *Lagerstroemia parviflora*. According to the User Agency, the tree cutting will be carried out in a phased manner followed by plantation with native species to compensate for the loss of tree cover.

D. Compensatory afforestation: According to the State Government, the User Agency will hand over 148.4123 ha. non-forest land at village Ratambi, Taluka Sangameshwar, Dist. Ratnagiri, to the Forest Department. The said non-forest land falls within the deemed 10 km ESZ of Sahyadri Tiger Reserve and is rich in biodiversity, having density more than 0.4. No plantation or crop improvement can be taken up on such biodiversity-rich area. Hence, this non-forest land can be mutated in favour of the State Forest Department and actual Compensatory Afforestation can be

taken up over nearest possible degraded forest land from the proposed area for diversion. As per the State Government, the Details of such degraded forest land will be submitted before final approval (mentioned in letter dated 02/08/2023).

1. Whether land for compensatory afforestation is suitable from plantation and management point of view or not: No. Non-forest land proposed to be handed over in-lieu of the forest area under diversion is not suitable for plantation. The Chiplun Forest Division has proposed plantation @ 1100 plants/ha in the said non-forest area, which is not possible (and should not be encouraged) because of the steep slopes, rocky area and biodiversity-rich landscape. As per the Rule 13 (1) of the Van (Sanrakshan Evam Samvardhan) Rules, 2023, "Provided further that if the non-forest land being made available for compensatory afforestation already bears vegetation of 0.4 canopy density or more, there shall not be an additional requirement of planting of trees on such land but a programme for improvement of the forest crop shall be implemented by the Forest Department in a time-bound manner:". Since the non-forest land is rich in biodiversity and forms part of the ESZ of the Sahyadri Tiger Reserve, no cropimprovement may be undertaken as it will deteriorate the existing biodiversity. Instead, the User Agency may be asked to :

i) deposit the cost of plantation on the nearest degraded forest land along with incentives, if applicable, as per the Rules. ii) deposit the cost of the protection of the said non-forest land.
