1. PROJECT DETAILS

(i) Short narrative of the proposal & project/ scheme for which forest land is required.

Radhikapur (West) Coal Block is situated in the Western most end of Talcher Coal field, in Chhendipada Tehsil of Angul District, with limiting Latitude of $20^057'28" - 20^059'42"$ North and Longitude of $84^051'00" - 84^054'47"$ East and forms part of Survey of India Topo sheet no 73-D/13 on a scale of 1: 50,000. The Block has been allocated jointly to M/s Rungta Mines Ltd, M/s Ocean Ispat Pvt Ltd and M/s OCL India Ltd by Ministry of Coal vide their letter no 13016/33/2005-CA-I dated 25/04/2006 and 13016/77/2006-CA-I dated 21/12/2009 (Annexure I respectively)-who in turn have formed a Joint Venture Company named M/s.Radhikapur (West) Coal Mining Pvt. Ltd.

The mining lease application for allocated block area for a period of 30 years has been submitted to Govt. of Odisha through Deputy Collector Angul on 08/10/2010 (D Form at Annexure – 3).

The block covers an area of 10.48 sq km in 8 (eight) villages like Barapada, Kusakila, Naupada, Kusakila Jungle Bar, Jhintipal, Putagadia, Balipata and Kosala in Chhendipada Tehsil of Angul District. Out of the total lease area of 1048 hectares i.e. 2589.608 Acres – the revenue forest (Gramya Jungle chhota jungle, Bada Jungle & Sabik Jungle) is 91.9292 hect i.e. 227.157 acres and scattered over whole of the property. The maximum extent of the block along trike direction (East-West) is 4.8 km that along dip direction is 3.5 km.

Out of total forest land of 91.9292 hect in the block area, **86.972** hect need forest diversion excluding 4.957 hector of forest land in safety zone.

There are no Reserved or Protected Forests in the lease area. The area also does not include protected areas like National park / Wildlife Sanctuary / Biosphere Reserve/ Tiger Reserve / Elephant Reserve or Elephant Corridor. The applied area also does not include places of Archeological importance.

The grade of the coal varies from D to G with total net geological reserves as 288.44 mt. The rated capacity of the mine is 6 MT/yr with a life of 25 yrs for opencast operations and 41 yrs for underground operations. The underground operations will be underneath the opencast operations and no new area will be broken /affected.

The Block has been allocated to Joint Venture Partners to meet the requirement of coal for their Steel, Cement and Captive Power plants located in the State of Odisha.

The project will transforms the economy of the area by generating direct employment to 1702 persons and double this number as indirect employment – bulk of which would go to local inhabitants.

The diversion proposal in Form-A in the prescribed format under F.C. Rules 2003 is being submitted for seeking approval for diversion of 86.972 ha. of Forest land under section-2 of the F. C. Act 1980 for utilization of mining and allied activities.

- (iii) Cost of the Project The Total cost of the project is Rs 600 crores exclusive of other statutory cost of compensatory afforestation, NPV,Safety Zone Management, cost of wild life management and royalty of trees etc
- (iv) Justification for locating the project in Forest Area
 - The mining is a site specific industry and can be undertaken only where there
 is occurrence of concerned mineral / rock and in this case 'coal'.
 - The block area has been allocated by a high level committee constituted by Govt. of India for the purpose and after scrutinizing various options coupled with need and requirement of raw material i.e. coal.
 - Lastly there is neither Reserve nor Protected forests in the area. The "Gramya Jungle" has very thin tree density.

Notwithstanding above, project proposes to have phase-wise reclamation of the used up area by plantation of native tree species in close consultation with the Forest Dep't. - Not only to restore but substantially enhance the greenery and canopy density in the area (Annexure - 20). In addition, Compensatory Afforestation has also been taken up in suitable non forest govt.

(vi) Employment likely to be generated

It is expected that about 1702 persons, predominately local persons will be employed and will be earning their livelihood when mining activities are in full swing. In addition about twice this number would be indirectly employed in ancillary activities. This would also lead to peripheral development of the surrounding villages / areas on account of health, education, recreational, sports facilities being created / sponsored by the project – leading to overall improvement in quality of life of the local and surrounding population in general.

2. Purpose wise break-up of the total land required.

The project requires 1048.00 ha. of land out of which 91.9292 Ha.(including sabik forest) is forest land. The purpose wise break-up of virgin forestland required for project is given in Table – 1. The details of Land Schedule are given in Vol. – II and summarized Land Schedule is at Annexure – 5. The forest area asked for diversion is based on actual requirement to meet the annual production target as per Mining Plan considered by Ministry of Coal to feed our own DRI Plants and Power Plants.

Coal Washery is proposed to be installed within the Mining Block for quality up gradation, simultaneously with mining operations. No separate virgin forest land is required for this purpose.

A 50m wide strip of land along Singhara Jore which forms northern and western boundary of the block and 7.5 m wide strip along rest of the block boundary will be maintained as safety zone – totaling to 40.908 ha of land including 4.957 hect. of forest land.
