Sub:- Administrative Approval and Expenditure Sanction for the new scheme of construction of Sewage Treatment Plant (STP)(3.0 mld capacity) at Rudraprayag town of Uttarakhand under Ganga Action Plan Phase-li (now NRCP) at an estimated cost of Rs.469.61 lakh (Rupees Four crore Sixty nine lakh and Sixty one thousand only)

Sir,

I am directed to convey the sanction of the President to the grant of Administrative Approval and Expenditure Sanction for the new scheme of construction of Sewage Treatment Plant (STP) (3.0 mld capacity) at Rudraprayag town of Uttarakhand under Ganga Action Plan Phase-II (now NRCP) at an estimated cost of Rs.469.61 lakh (Rupees Four crore Sixty nine lakh and Sixty one thousand only). The cost is to be shared on 70:30 basis between Govt. of India and the State Govt. of Uttarakhand. The Govt. of India's share at 70% comes to Rs.328.73 lakh and the State Govt.'s share at 30% comes to Rs.140.88 lakh.

- Break-up of the sanctioned cost is at Annexure-I.
- Administrative Approval and Expenditure Sanction is subject to the following conditions:-
  - The funds for the project will be released in suitable installment and the next installment will be released only after scrutinizing the Utilization Certificate and Progress Report in respect of the previous installment and ensuring that respective share of the State Government, if any, has been received.
  - The Time Schedule for completion of the scheme is 2 years from the date of this sanction and the project completion schedule and other conditions are to be strictly observed.
  - iii) Any project cost overrun for whatsoever reasons during implementation of scheme is to be met entirely by the State Government/Implementing Agency GOI liability is limited to Rs.328.73 lakh

Operation & Maintenance (O&M) is the responsibility of the implementing Agency/State Govt. and cost overrun for O&M is to be met by State Government & Implementing Agency.

v) The implementing agency have to provide the actual sewage characteristic after reliable 3<sup>rd</sup> party testing in the tender document.

vi) The technology choice for STP will be kept open to allow the latest technology to become available during bid process.

vii) The implementing agency need to ensure removal coliform by appropriate technology such as U.V. radiation.

- viii) It should be ensured that arrangement of safe sludge disposal after the treatment will be made as part of the O&M procedure to be borne by the State Govt.
- 4. Approval is also subject to compliance of conditions issued vide Addl. Secretary and Project Director's D.O.A-28011/1/98-NRCD-II dated 6-7-1998 (copy enclosed).
- 5. Release of funds for this scheme will be linked to:-
  - (a) Fulfilment of legal and physical requirement by the State Government to enable local bodies to augment their resources and Operation & Maintenance of the assets created under the National River Conservation Plan.
  - (b) Foolproof arrangement being made by State Govt. to tackle non-point sources of pollution including industrial pollution and;
  - (c) Constitution of Project Monitoring Cell under Divisional Commissioner which should meet and monitor the progress regularly.
- The expenditure of the scheme is debitable to Major Head "3435"-04.101.06.02.31-Grants-in-aid-Other Schemes- National River Conservation Plan (NRCP) under Demand No.30-Ministry of Environment & Forests for the year 2009-2010 (Plan).
- 7. This issues under the powers delegated to the Ministry of Environment & Forests and with the approval of Secretary, Ministry of Environment & Forests as well as with the concurrence of IFD vide Dy.No.1523/JS(FA)/F/09 dated 3-9-2009.
