Dear Sir.

This is in reference cited above, resurvey for the forest sections as per the directions given during various meetings with officials at PCCF, Guntur and IT Wing, Forest Office, Hyderabad from 03 May 2017 to 22 June 2017.

The resurvey work has been undertaken from 28 Jun 2017 to 07 Jul 2017 with Dual Frequency Differential Global Position System (DGPS) receiver with observations of 15 to 20 Minutes at each point. The points are also connected to Survey of India (SOI) Ground Control Point (GCP), located at Zilla Court, Madanapalle Mandal, Chittoor (about 50 km from proposed NH 4 alignment). Observation has been done for 8 hours at the SOI GCP and the instrument details used for the forest survey (make : Trimble, Model No.R-4 & Frequency: Dual).

The survey has been carried out to form a closed polygon, in the presence of the authorized persons from your corresponding Range Forest Offices of Chittoor District. Data acquired using DGPS has been processed and the co-ordinates have been plotted. Compartment wise forest area required to be diverted has been arrived at based on the drawings generated.

The area calculations based on the DGPS Observations are as follows:
