We MP Power Transmission Package II Limited are developing a Transmission system consisting of 28 transmission lines across Madhya Pradesh under the scheme "Development of intra-state transmission work in M.P. through Tariff Based Competitive Bidding : PACKAGE- II". The Project is initiated by Madhya Pradesh Government under Tariff Based competitive bidding whose bid process coordinator was REC Power Development and Consultancy Limited. The project is aiming to improve the reliability of power supply and accreting 24 x 7 power supply across state. . The project has been approved under section 68 of Electricity Act 2003 from Power Ministry Madhya Pradesh vide F-3-02/2020/13 dated 26<sup>th</sup> August 2021.

Accordingly, one of the 28 lines i.e. Malanpur 220-MES Gwalior 132kV DCDS Line, is passing through the forest area in Gwalior District. The total forest area through which transmission line is passing and need to be diverted is 1.5684 Hectare in Gwalior Range of Gwalior Forest Division. We have submitted the Forest Diversion Proposal to Nodal officer to which it has been instructed to submit a copy of proposal to your good office for processing of FRA Certificate in accordance with "The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right Act) 2006".

We need FRA Certificate from your good office in prescribed format of MoEF&CC for enclosing it along with forest diversion proposal as per Forest (Conservation) Act 1980.
