As per the instructions, it is proposed to lay electrical lines by utilizing 11 KV Aerial Bunched Cable/Insulated Conductor with required width of 2.4 Mts corridor instead of earlier proposed 11 KV bare conductor with width of 7.0 Mts corridor for 13 Nos. Wild Life covered villages at Bhadradri Kothagudem District and requested to provide data authentication for revised DGPS maps by considering 2.4 Mts corridor to Hon'ble Principal Chief Conservator of Forest/Hyderabad vide reference 12th cited.




