Adverting to the subject cited it is to inform that the Authorized signatory Reliance JIO infocom Limited vide reference 1st cited has uploaded proposal for Diversion of 0.24 Ha of forest land for laying of Optical fiber cable along the road within in the existing right of way passing through forest land falling in paderu Division. After verification of the proposal certain short comings have been noticed and requested the user agency was requested to attend the short comings and submit the proposal vide reference 2nd cited. Accordingly the user agency has attended to the short comings and uploaded the proposal through online vide reference 3rd cited.

Five (5) sets of the hard copy submitted by the user agency are sent along with this letter to the Divisional Forest Officer, Paderu for processing the same under Forest (Conservation) Act, 1980 and the guidelines issued there under.

The Divisional Forest Officer, Paderu Division is requested to critically examine the requirement of forest land for the above project and satisfy himself that the requirement of land for the project is unavoidable. He is requested to examine the proposal in totality and furnish all the necessary details in the Part-II. He is also requested to carryout site inspection and enclose the field inspection report with photographs of the spots visited and same included in the FIN; take up enumeration of trees to be felled, if any, in the proposed area for diversion and submit Abstract of enumeration, species and girth class wise in the following Proforma:

He is requested to specifically mention about the source and / or method for indicating the density of vegetation, vulnerability to soil erosion, the impact of the project on the

adjoining flora and fauna and also suggest mitigative measures for the protection of flora and fauna and record specific recommendation or otherwise for the project and submit the same in Eight (6) sets through the Chief Conservator of Forests / Conservator of Forests, Visakhapatnam within the stipulated time.

The Divisional Forest Officer, Paderu Division, is further requested to specifically mention if the proposed area is falling in National Park / Wild Life Sanctuary or within the Eco-sensitive zone and also mention the exact distance from the nearest WLS / NP duly enclosing the location map.

He is also requested to examine the proposal in the light of guidelines issued regarding RoFR Act vide F.No. 11-9/98-FC(PT) dt 05.02.2013 (copy enclosed) and submit a certificate duly stipulating that the proposal seeking prior approval of Central Government under the Forest (Conservation) Act -1980 for projects like construction of roads, canals, laying of pipe lines/ Optical fibers and transmission lines etc.. where linear diversion of use of forest land in several villages are involved, unless recognized rights of PTG/PA being affected are exempted from the requirement of obtaining consent of the concerned Grama sabha's as stipulated in Clause (C) read with clause (b), (e) and (f) in second Para of the Ministry's said letter dt. 03.08.2009

He is requested to submit the proposal in complete shape duly filling information in Part-II and with specific recommendation within the stipulated time through the Chief Conservator of Forests / Conservator of Forests, Visakhapatnam along with information in check slip, for further consideration of the proposal.

He is specifically directed to upload information pertaining to Part-II of the proposal in the Ministry's website (www.forestclearance.nic.in) and furnish attested copy of the acknowledgment slip with the proposal.

Early and time bound action is requested.
