In the reference 2<sup>nd</sup> cited, the PCCF &HoFF, TS, Hyderabad has issued authentication report on the DGPS survey carried out for 9 roads as mentioned therein and requested the PR Department to submit proposals in the required sets in both online and offline mode for further processing of the proposals.

Proposals mentioned at Sl. No. 6 i.e., road from Markodu to Pedduru, DGPS authentication has been issued for an extent of 1.9720 Ha (length 1314.657 m X width 15m).

In this connection, it is submitted that based on the terrain of the road and as per the provisions mentioned in the sanctioned estimates, the width proposed for formation is restricted to 10 m only to that of 15m.

Accordingly, we have prepared proposal for diversion of forest land to an extent of 1.3146 Ha or 1.32 Ha, duly restricting the width to 10 m.

We also submit that this proposal doesn't require permission under Environmental Protection Act, 1986 and its subsequent amendments; as such proposals under WL format have not been submitted. This proposal has also been uploaded on Ministry's portal.

In view of the above, the proposals under FCA act format in (8) sets are submitted herewith duly countersigned by the Chief Engineer, PR Dept, Hyderabad with a request to forward the same to the Forest Divisional Officer /District Forest Officer concerned for further processing of the proposal, as this project is to be completed in a time bound manner as the funds realized from the Government of India will be lapsed by 31.03.2019, if the same are not utilized in the stipulated time.
