**Sir,**

This has reference to the above letters vide which you had returned the revenue forest diversion proposal of 4000 MW Odisha UMPP being setup in Sundargarh district, Odisha and had advised us to resubmit the proposal online through "Online Submission and Monitoring of Forest Clearances Proposal" (OSMFCP) portal of MoEF. Accordingly, we had submitted the proposal for diversion of 17.02 ha of Revenue Forest land within the plant boundary online on 19.06.2015 through OSMFCP portal.

Subsequently, the Forest department sought certain details on 22.06.2015 and 06.07.2015 which were uploaded on 03.07.2015 and 06.07.2015. The proposal has been accepted by the Forest department today and OIPL has been advised to submit a hard copy of the proposal.

Accordingly, we are submitting hard copies of the proposal (7 nos.) for further processing. The proposal comprises of the following :

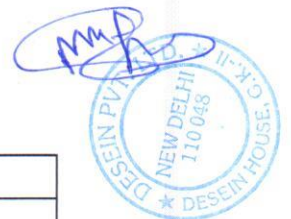
