The Divisional Engineer, Highways, Chennai Metropolitan Development Plan Division-1, Chennai has uploaded online forest clearance proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 4.46ha of forest land in Vandalur Reserve Forest for formation of Tambaram Eastern Bypass road branching from km 17/4 of Malmalong bridge-Irumbuliyur road from Rajakilpakkam via Agaramthen road towards Perungalathur at km 0/0-9/300 in Chengalpattu District under proposal No. FP/TN/Road/148656/2021.
  - i. This proposal was recommended to the Government vide Principal Chief Conservator of Forests reference 2<sup>nd</sup> cited for obtaining approval from the Government of India for diversion of forest land.
  - ii. Similarly, the Divisional Engineer, Highways, Chennai Metropolitan Development Plan Division-II Chennai has uploaded online forest clearance proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 0.95472Ha. of forest land in Vandalur Reserve Forests for construction of Road over Bridge in lieu of LC No.32 in between Tambaram and Vandalur Railway Station near Perungalathur in Chengalpattu District under proposal No. FP/TN/Road/151930/2022.
  - iii. This proposal was recommended to the Government vide Principal Chief Conservator of Forests reference 4<sup>th</sup> cited for consideration of the Government and to issue State-I in principal approval for diversion of forest land.
  - iv. Since this project involves felling of 204 number of spontaneous trees, the projects would be permitted only after the concurrence of the Regional Office, MoEF&CC, Chennai. Hence concurrence of the Regional Office, MoEF&CC, Chennai has been requested by the Government of Tamil Nadu.
  - v. For the above two forest clearance proposal, name of the User Agency has been reported as Chief Engineer, Metro, Highways Department, HRS Campus, Guindy, Chennai.
2. Government of Tamil Nadu, ECC&F Department has forwarded the above forest clearance proposal for their concurrence and requesting concurrence for felling of spontaneous trees.


3. Government of India, MoEF&CC, Regional Office, Chennai in the reference 5<sup>th</sup> cited (copy enclosed) has informed to the State Government that, the Chief Engineer, Metro, Highways Department has submitted two proposals ie., FP/TN/ROAD/1519301/2022 for 0.95472Ha. and FP/TN/ROAD/1486561/2021 for 4.46Ha and noted that above mentioned two proposals are in same stretch and continuous in alignment. The State Government vide letter dated 03.08.2023 requested the Regional Office, Chennai to convey approval for felling of 204 spontaneous trees under proposal No. FP/TN/ROAD/151930/2022 involves diversion of 0.95472Ha. and whereas submitted the subject proposal to this office for approval under FCA, 1980.

- i. It has informed that, splitting of same stretch of road in to smaller area shall not be done and especially for linear proposals, proposal shall be submitted for its entirety. By splitting of proposals, competent authority to decide on such proposal will also change as per the delegation of powers and such artificial splitting is not permissible.
- ii. The Divisional Engineer, Metro, Highways Department, CMDP Division-I and the Divisional Engineer, Highways, Chennai Metropolitan Development Plan Division-II are requested to withdraw the above two proposals from the PARIVESH and to submit a fresh proposal for the revised area by combining 0.95472Ha. + 4.46Ha. = 5.41472Ha.
- iii. In this regard, a copy of the reference 6<sup>th</sup>,7<sup>th</sup>,8<sup>th</sup> and 9<sup>th</sup> cited above is enclosed herewith for necessary follow up action.

The User Agencies are requested to withdraw the above-mentioned proposals and to submit a fresh proposal for its entirety of the road work adhering the guidelines issued under the Forest (Conservation) Act, 1980.

Attention of the Chief Conservator of Forests is invited to the references cited.

1) The Divisional Engineer, Highways, Chennai Metropolitan Development Plan Division-I, Chennai has uploaded online forest clearance proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 4.46 ha of forest land

in Vandalur RF for formation of Tambaram Eastern Bypass road branching from km 17/4 of Malmalung bridge-Irumbuliyur road from Rajakilpakkam via Agaramilheri road towards Perungalathur at km 0/0-9/300 in Chengalpattu District under proposal No. FP/TN/Road/148656/2021.

i) This proposal was recommended to the Government vide Principal Chief Conservator of Forests reference 2<sup>nd</sup> cited for obtaining approval from the Government of India for diversion of forest land.

ii) Similarly, the Divisional Engineer, Highways, Chennai Metropolitan Development Plan Division-II Chennai has uploaded online forest clearance proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 0.95472 ha of forest land in Vandalur RF for construction of Road over Bridge in lieu of LC No. 32 in between Tambaram and Vandalur Railway Station near Perungalathur in Chengalpattu District under proposal No. FP/TN/Road/151930/2022.

iii) This proposal was recommended to the Government vide Principal Chief Conservator of Forests reference 4<sup>th</sup> cited for consideration of the Government and to issue Stage-I in-principle approval for diversion of forest land.

iv) Since this project involves felling of 204 number of spontaneous trees, the projects would be permitted only after the concurrence of the Regional Office, MoEF&CC, Chennai. Hence concurrence of the Regional Office, MoEF&CC, Chennai has been requested by the Government of Tamil Nadu.

v) For the above two forest clearance proposals, name of the user agency has been reported as Chief Engineer, Metro, Highways Department, HRS Campus, Guindy, Chennai

i) It has been informed that, splitting of same stretch of road in to smaller area shall not be done and especially for linear proposals, proposal shall be submitted for its entirety. By splitting of proposals, competent authority to decide on such proposal will also change as per the delegation of powers and such artificial splitting is not permissible.

ii) Considering the above facts, it is requested that State Government may inform all stake holders including forest department Officials not to split the proposals in future. Further, the UA i.e. Chief Engineer, Metro, Highways Department may be directed to withdraw the above two proposals from the PARIVESH and to submit a fresh proposal for the revised area by combining 0.95472 ha + 4.46 ha= 5.41472 ha.

iii) As the combined area will be more than 5 ha, the revised proposal needs to be processed through Project Screening Committee (PSC) as per the provision of FC rules 2022. Further, it is also noticed that, the proposed CA scheme is not as per the provision of FC rules 2022, hence, Nodal Officer may be advised to re-examine the CA scheme and to submit appropriate CA scheme along with the said revised proposal.

4) In this regard, a copy of Government letter 6<sup>th</sup> cited above is enclosed herewith for necessary follow up action.

The user agency may be informed to withdraw the above-mentioned proposals and to submit a fresh proposal for its entirety of the road work adhering the guidelines issued under the Forest Conservation Act, 1980.


