Sub: Forests – Proposal (FP/TN/RAIL/152033/2022) for diversion of forest land of 28.6132 ha. for restoration of Rail connectivity between Rameswaram and Dhanushkodi in Rameswaram Reserved Forest in Ramanathapuram District in favour of Deputy Chief Engineer, Construction IV, Arasaradi, Madurai (Railways) – Proposal rejected – Regarding.

I am directed to invite your attention to the references cited. The Deputy Chief Engineer, Construction IV, Arasaradi, Madurai (Railways) has uploaded a proposal (FP/TN/RAIL/ 152033/2022) in PARIVESH portal for diversion of 28.6132 ha. of forest land for restoration of Rail connectivity between Rameswaram and Dhanushkodi in Rameswaram Reserved Forest in Ramanathapuram District for a period of 20 years under section 2(1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.

- 2. The District Forest Officer, Ramanathapuram Division and the Conservator of Forests & Field Director, Srivilliputhur Megamalai Tiger Reserve, Madurai and Additional Principal Chief Conservator of Forests (Forest Conservation Act), have recommended the above proposal.
- 3. In the reference 5<sup>th</sup> cited, the proposal was recommended and sent to Government with a request to forward the same to Government of India for obtaining the approval from the competent authority for the project proposal, subject to certain conditions.
- 4. Considering the importance of the issue, a meeting was held under the Chairmanship of Chief Secretary to Government with Principal Secretary to Government, Environment, Climate Change and Forests Department on 02.08.2024 at 5.00 P.M.
- 5. During the above said meeting, it has been decided that, considering the ecological impact on flora, fauna and marine eco-system, the proposed sanctuary for Greater Flamingo and nesting sites of Olive Ridley turtle and the fact that it is a railway line to nowhere, wherein there are no human settlements or habitations, it is not advisable to disturb the fragile eco-system. It will also be of no help to any cargo movements as there are neither habitations nor any cargo jetties. Therefore, it was concluded that it will be ecologically disastrous to go ahead with the project and hence the request for diversion of forest land may not be agreed to.
- 6. It is informed that a Memorandum has been presented to the Hon'ble Prime Minister of India by the Hon'ble Chief Minister of Tamil Nadu on 08.04.2023 in respect of dropping the project for formation of New Broad Guage Line between Rameshwaram and Dhanuskodi which is reproduced as below:-

"On 17<sup>th</sup> August 2022, Administrative Sanction has been accorded for initiating the process of land acquisition and land transfer for the formation of New Railway Line between Rameshwaram and Dhanuskodi in Ramanathapuram District, based on the request of the Southern Railways.

However, the process of 3(2) notification for land acquisition temporarily stopped on account of national highway alignment interfering with alignment of Rameswaram – Dhanuskodi proposed New Railway Line.

Southern Railway has reiterated their request for land alienation of Government land of 43.82 hectares and forest land of about 28.61 hectares early so as to commence the work as soon as possible.

Considering the fragile eco-system existing along this eco sensitive zone, the Government of Tamil Nadu is of the opinion that this stretch is not suitable for forming a New Railway Line. Therefore, this project may be revisited or analysed critically based on the inputs from the experts on environmental issues or may be dropped due to the unsustainable nature of this project".

7. As per Van (Sanrakshan Evam Samvardhan) Rules, 2023, the sub rule 17 of Rule 9 refers the following:-

"Where the State Government or Union territory Administration, as the case may be, decides not to dereserve, divert for non-forest purposes or assign on lease the forest land as indicated in the proposal, the same shall be intimated to the user agency by the Nodal Officer".

- 8. Based on the decision taken during the meeting held on 02.08.2024 under the Chairmanship of Chief Secretary to Government, and based on the rejection of project proposal by Transport Department, the Government have carefully examined the proposal in detail and decided to reject the proposal for diversion of 28.6132 ha. of forest land for restoration of Rail connectivity between Rameswaram and Dhanushkodi in Rameswaram Reserved Forest in Ramanathapuram District.
- 9. In this connection, I am therefore directed to request you to take necessary action on the above subject proposal as per Rule 9 (17) of Van (Sanrakshan Evam Samvardhan) Rules, 2023.

MINUTES OF THE MEETING UNDER THE CHAIRMANSHIP OF CHIEF SECRETARY TO GOVERNMENT HELD ON 2.8.2024 REGARDING PROPOSED DIVERSION OF FOREST LAND OF 28.6132 HA. FOR RESTORATION FOR RAILWAY CONNECTIVITY BETWEEN RAMESHWARAM AND DHANUSHKODI AT RAMESHWARAM RESERVE FOREST IN RAMANATHAPURAM DISTRICT.

The list of participants is given in the Annexure.

A presentation was made to the Chief Secretary to Government, regarding the proposal by the Deputy Chief Engineer, Southern Railways for diversion of forest land. During the presentation, it was informed that the entire extent of forest land which is sought by the Southern Railways for providing rail connectivity between Rameshwaram and Dhanushkodi is ecologically fragile, which has seen significant adverse impact, after the new highways was laid in the area.

It was informed that the forest area have twelve differenttree species numbering 1338, and animals such as Star tortoise, Sand Boa, Black Naped Hare, Indian Black Turtle, Indian Mangoose are reported and the lagoon area frequented by Greater Flamingo and State Government has proposed to establish a sanctuary for the same. The proposed site has mudflats supporting coastal eco-system.

It was also informed that the marine area is rich in coral reefs, sea cucumber, dolphins, and the coastal area has OliveRidley Turtles nesting sites.

The Chief Secretary to Government sought the details of the habitation and population in the project area. It was informed that the

entire stretch in the Kothandaramar lagoon is uninhabited by human beings and Dhanushkodi is a ghost town without any human settlements and diversion of reserve forest will have deleterious effect to the proposed Greater Flamingo sanctuary and nesting Olive Ridley Turtles apart from immense ecological damage to the fragile eco-system.

After the detailed deliberations, considering the ecological impact on flora, fauna and marine eco-system, the proposed sanctuary for Greater Flamingo and nesting site for Olive Ridley turtle and the fact that it is a railway line to nowhere, wherein there are no human settlements or habitations it is not advisable to disturb the fragile eco-system. It will also be of no help to any cargo movements as there are neither habitations nor any cargo jetties.

In view of the above, it was decided that it will be ecologically disastrous to go ahead with the project and hence the request for diversion of forest land may not be agreed to.

Considering all the above, Government of India may also besuitably informed, to abandon theproject of formation of railway line to Dhanushkodi.

This is in reference to the project for the formation of New Broad Gauge Railway Line between Rameswaram and Dhanushkodi.

- 2. On 17<sup>th</sup> August 2022, Administrative Sanction has been accorded by this department based on the request of the Southern Railways for initiating the process of land acquisition and land transfer for the formation of New Railway Line between Rameswaram and Dhanushkodi in Ramanathapuram District.
- 3. In this regard, the Southern Railway has requested to commence the work for land alienation of Government land of 43.82 hectares and forest land of about 28.61 hectares early as soon as possible.
- 4. While discussing the matter with experts on various issues including environment it has been brought out that this region is ecologically very sensitive. It was felt that, considering the fragile eco-system existing along this eco sensitive zone, the Government of Tamil Nadu is of the opinion that this stretch is not suitable for forming a New Railway Line. Therefore, it was felt that, it is not worth to pursue this project.
- 5. Regarding this issue, a Memorandum has been submitted to Hon'ble Prime Minister of India through Hon'ble Chief Minister of Tamil Nadu on 08.04.2023 with a request to drop the project for "Formation of New Broad Gauge Railway Line between Rameswaram and Dhanushkodi".
- 6. I would like to request you to drop the project for the "Formation" of New Broad Gauge Railway Line between Rameswaram and Dhanushkodi" due to the un-sustainable nature of this project.
