5. In reply to point no. 14 & 15, original hard copy of FRA and Part IV & V is still not submitted.  
**Action Required:** State Govt. may submit the original hard copy of FRA and Part IV & V to this office.
6. The KML file uploaded for the proposed road seems to be incorrect.  
**Action Required:-** State Govt. may upload correct information regarding this.
