


i) Online proposal bearing on FP/JK/ROAD/46939/2020 received on dated 08.09.2021

Sir.

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 0.305 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

- After careful examination of the above-mentioned proposal of the Govt of J&K, the following information/clarification are still required to be submitted:
 - Legal status of the user agency is given Central government where as it should be i. state government.
 - Employment detail in the proposal is submitted as NIL. Need to be corrected. ii.
 - Two dumping sites mentioned in the MDP plan whereas KML shows only one iii. dumping sites. This need to be corrected.
 - Land suitability certificate of the proposal is having area 01 ha, while CA plan is iv. submitted for 0.80 ha. Need to be corrected.
 - Enumeration list is given for 31 trees while total no. of trees to be felled is 35 as mentioned in Part-II 4(ii). Fresh enumeration list to be submitted.
 - Muck disposal plan is ambiguous as area mentioned in MDP for each dumping VI. site is 0.002 ha, while as per the 'forest area calculation sheet' the area is 0.025 ha for each dumping site. Also KML of the proposal shows only one dumping site whereas two sites proposed in the proposal as per MDP.
- The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
