

No.212 of W.P. (C) No.562 of 2009 after conducting joint survey of the proposed area.

1. Form-A under Rule 6 of Forest (Conservation) rules, 2003.
2. Digital map of the proposed area with DGPS readings
3. Map showing the details of protected area in 10 km radius from the boundary of area proposed.
4. Top Sheet 1:50000 duly marking the area proposed for diversion.
5. Under taking for payment of NPV and additional NPV.
6. Under taking for payment of Compensatory Afforestation Amount and other charge.
7. Certificate in Form-I of FRA 2006 issued by Deputy Commissioner, Ballari.
8. Details of non-forest land to be transferred for raising Compensatory Afforestation along with Maps and Other Details.
9. Bare minimum area requirement certificate.
