On scrutiny of the above said diversion proposal sent vide your memo under reference the following discrepancies are noticed.-

- 1) In part-I of online application, the KML file of CA land of 4.047 ha (Gumaguda) has been uploaded instead of uploading KML file of forest area proposed to be diverted (3.003 ha in Hatibari RF).
- 2) In part-I of online application, the Topo sheet of CA land of 4.047 ha (Gumaguda) has been uploaded instead of uploading Topo sheet of forest area proposed to be diverted (3.003 ha in Hatibari RF).
  - 3) In part-I of online application, the Geo referenced map of CA land of 4.047 ha (Gumaguda) has been uploaded instead of uploading Geo referenced map of forest area proposed to be diverted (3.003 ha in Hatibari RF).
- 4) In part-I of online application details of land identified for Compensatory Afforestation has not been reported at point No.L.
- 5) In part-II of online application density of vegetation has been reported as density =0.5 and Eco class=2 where as in site inspection report of DFO it has been reported as density=0.5 and Eco class= 3.
- 6) In part-II of online application, total financial outlay for CA has been reported as Rs 52.79628 lakh where as in CA scheme it has been calculated as Rs 52.22184 lakh.
- 7) In part-II of online application, details of non-forest land identified for CA is to be reported in proper format of portal.
- 8) An undertaking by user agency to bear the cost of CA has not been furnished in diversion proposal.
- 9) In joint verification report / suitability of CA land, boundary description has not been reported.
- 10) Point-wise compliance on the observations pointed out by the CCF (Nodal) has not been furnished.

The required data may be uploaded on Parivesh portal and submit the revised Part-I, Part-II, site inspection report etc with the D.P. to this office for taking further action.
