

2. The point wise reply with respect to the observation raised by the Integrated Regional Office, Chandigarh, MoEF&CC vide letter referred to above is given as follows: -

Sl. No.	Observation	Compliance
1.	In reference to observation No-2, REPLY NOT ACCCEPTED , justification for broken area/detail of violation is not found uploaded. Since, broken area has been marked in the Forest land (rather than the road which is mentioned in revenue records as Gair Mumkin rasta) in the KML. Also, a document has been uploaded in additional document in sl. no. 2, part-II, wherein it is submitted that existing road falls in private land and no construction found in forest land but the document is signed by RFO and not authenticated by DFO. Therefore, DFO concerned shall upload the comments along with Site inspection report.	In this regard it is submitted that a site inspection of the forest land involved in the proposal has been done by undersigned on dated 12 the September, 2025 and it has been found that no violation of the Forest (Conservation) Act, 1980 on the forest land at the site. The detailed Site Inspection Report is enclosed as "Annexure-A".

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF
(For the Forest land to be diverted under FCA)

A proposal has been submitted by this office from user agency Executive Engineer, HPPWD Rural Division Dhami, for the diversion (under FCA 1980) of 0.7882 hectare of Forest land for non-forestry purpose. The subject envisages the use of Forest land for construction of link road from Mandhorghat to Golan (Km 0/00 to 1/810), District Shimla in Himachal Pradesh Tehsil and District-Shimla, HP. The site inspection of the land involved in the proposal has been done by me on dated 12th September, 2025.

During the inspection, it was found that the land proposed for diversion is forest land measuring 0.7882 hectare. A **Kacha path** already exists at the site, and no trees are involved in the proposed diversion. The broken area as mentioned is basically a Kacha path & no violation has occurred. The remaining stretch visible on-site constitutes an existing path/mule track, As mentioned in the revenue records and certificate issued by the Pradhan, Gram Panchayat Mandhol, a **Gair Mumkin Rasta** is already in existence the width of this path varies from 3 meters to 5-6 meters. No construction activity of any kind has been carried out by the Himachal Pradesh Public Works Department on the forest land. Hence, no violation of the Forest (Conservation) Act, 1980 on the forest land at the site.

In view of above, the construction of road is very important/necessary for local people of this area therefore proposal is recommended for approval.
