Madam/Sir,

I am directed to refer to the Government of Odisha's letter No. 10F (Cons.) 179/2015/16479/F & E Bhubaneswar dated 15.09.2015 on the above mentioned subject for seeking prior approval of the Central Govt. under Section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. Further, it is informed that the proposal along with additional information submitted by the State Govt. vide letter dated FE-DIV-FLD-0101-2021-12349/FE&CC dated 18997/9F (MG) -18/2015 dated 11.09.2025 was considered by the Advisory Committee Meeting held on 26.09.2025. After the examination of the proposal, the Advisory committee has deferred the proposal; for want of the following document/ information:

i. The 10.594 hectares area which is already diverted is represented by multiple small, scattered patches throughout the proposed lease, rather than as a single consolidated block. Therefore, the State shall verify the precise location of the 10.594 hectares of diverted area and submit a detailed layout of the same supported by documentary evidence.
