In inviting a reference to captioned subject, I am directed to inform that the DIG of Forests (C), Gol, MoEF&CC, Regional Office, Bhubaneswar vide letter dtd.30.07.24 with a copy to you and the User Agency(copy enclosed) had intimated that as per DSS analysis/ Google imagery, the user agency has used the forest land for non-forestry purpose in several patches of forest land (9 places) without prior approval under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. Thus, the proposal involves violation. Hence, MoEF &CC, Regional Office has requested to submit the proposal to the MoEF&CC, New Delhi as per Rule 10 (2) of Van (Sanrakshan Evam Samvardhan) Rules, 2023.

But no detailed report on the violation has yet been received from you for taking further action at this end.

With subject and reference cited above. I am directed to inform that the point wise reply furnished by State Govt, vide letter under reference-2 was examined in this office. It is observed that as per DSS analysis/Google imagery, the user agency has used the forest land for non-forestry purpose in several patches of forest land (9 places) without prior approval under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. Thus, the proposal involves violation. As per Rule 10 (2) of Van (Sanrakshan Evam Samvardhan) Rule, 2023, the above proposal may be submitted to MoEF&CC, New Delhi for further necessary action.
