विषय: Diversion of 0.6806 hectare in favour of Sanjeev Hydro Projects Private Limited VPO Sauhora Tehsil & District Kangra for construction of Lower lku Small llydro Electric Project (IMW), within the jurisdiction of Dharamshala Forest Division, Distt. Kangra, H.P. (Online Proposal No. FP/HP/HYD/41472/2019).

महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउतर का ध्यानापूर्वक अवलोकन करने के पश्चात प्रस्ताव में अभी भी निम्नलिखित कमियां पाई गई है:—

KML of diversion area shows that road is proposed upto N 32 10 31.68 E 76 24 32.65. The approach to this road from nearest existing road may be clarified as existing road is far away from this location.

- 1. It has been observed from KML file that Transmission Line is proposed upto few distance from house where no sub-station exist. Therefore, following documents/clarification may be provided:
  - i. Detailed power evacuation plan mentioning the Evacuation Plan from Power House of extant project upto sub-station of HPSEB Ltd. may be provided.
  - As per TEC, "for evacuation of power, the IPP shall interface this project in joint mode through existing 1.6 km/11 KV Kand-K Kardiana feeder". Accordingly, Grid Plan showing Power Evacuation of extant project may be provided.
  - iii. Joint Evacuation Agreement between Lower IKu and Lower IKu-I for Joint Evacuation of Power from may be provided.
- 2. As per NOC of Irrigation of Public Health Department, "The project weir should be proposed downstream of head weir of FIS Nirjul Kuhl and Machhul Kuhl and its tail race point should be 100 meter above proposed Fatt dhani Di Kuhl". It has been observed from KML file that head weir of one of the Kuhl in the area is located below the weir site of proposed project. The comment in this regard may be provided. Further, location of these Kuhls of IPH may be marked in KML file and Layout Plan. Also, an Undertaking to the effect that "all the conditions stipulated in NOC of IPH department shall be adhered strictly by User Agency" may be provided.
- 3. As per MoEF&CC directions given on 13.05.2022 for all Hydel Projects of Himachal Pradesh, following documents may be provided:-

- i. Detailed list of approved/existing proposed project in the River Basin Area/Landscape showing Power Evacuation/Transmission Plan of each HEP along with their impacts on the ecology of the area may be provided.
- ii. A KML file and geo-referenced map showing boundaries of nearest Protected Areas (PAs) and their Eco-Sensitive Zones (ESZ) along with the distance of each HEP in the area/Landscape from these PAs and their ESZ may be provided.
- iii. The detail regarding volume of water available in Nallah in lean season in which extant project is proposed, water to be utilized to run the turbine/power project and maintenance of e-flow may be provided. Also, comments regarding ensuring of e-flow during lean season may be provided.
- iv. The status of River Basin Study of Beas River along with carrying capacity of the Beas Basin in terms of power generation, how much is utilized so far and how much is yet to be utilized by the State may be provided.
- v. The status of CA land whether it is in possession of State Forest Department or not may be provided with supporting document.
- vi. The approved copy of Assessment of Environmental Managenement Systems and Impementation, Capacity document along with its recommendations to mitigatae the adverse effect of the Hydel Projects may also be provided.
