1. The Justification for locating the project on forest land uploaded online in part-I is different to the hard copy placed in proposal folder
2. Cutting and application of fluid in proposal folder are not accepted.
3. The toposheet (online & offline) is not clearly visible.
4. Digital map and KML file is differ.
5. The case should be submitted in this office along with enumeration list/abstract prepared by RO concerned on following format:-
