Sir,

Please refer to the subject and I am directed to request to furnish the following documents / information / clarification at the earliest for further processing of the proposal;

- The proposal is for improvement of the existing Korampallam surplus course bridge with 14.87 mts width on the northern side and 7.10 mts width on the southern side in the mangrove area. It was reported that a total of 109 spontaneously grown mangrove plants are present in the proposed area for diversion. Hence, a detailed report on the how the work is proposed to be executed without disturbing the mangrove spread area may be furnished.
- As no trees are proposed to be felled and the total area of diversion is less than 1.0 ha, a justification for proposing CA scheme (at a cost of Rs. 17.24 lakhs) may be furnished.
- A point wise compliance report on the de-reservation approval letter of the GoI, dated 12.05.2015 may also be furnished, please.
