Please refer to the subject and reference cited above and I am hereby directed to request to furnish the following documents / clarification to this office for further processing of the proposal;

1. The kml file uploaded in the online application against the subject proposal appears to be wrong and same needs to be rectified.
2. It appears that, the DGPS readings of the non forest land identified for Compensatory Afforestation is showing inside the reserve forest, which needs to be clarified.
3. The proposed area is showing equally on both sides of the road. Whether the proposal is for expansion of the existing one on both sides of the road (or) it is newly proposed on another side is not clear. If it is a new proposal then it may be proposed for expansion on the existing side. If not expansion of the existing one, but is a proposal for new one, then proper justification needs to be given, since it is not a site specific activity.
4. The status of online proposal in the web portal shall be rectified and forwarded to the Regional Office, Chennai.
