Sub:- Submission of Diversion proposal of 39.59 hac forest land under Kendumundi Range for relocation of villages situated in buffer area of Similipal Tiger Reserve.

Ref:- Your Memo No.4582, dt.21.09.2017.

On scrutiny of the above Diversion Proposal submitted in your memo under reference, the following discrepancies are noticed which may be complied within week for taking further necessary action at this end.

i) In item No.-2 of Part-II Application Form you have mentioned the legal status of Forest Land as PRF-39.59Ha. whereas you have mentioned PRF-34.40Ha. and Revenue Forest-5.19Ha. in your site inspection report which may be clarified.

ii) The abstract of tree enumeration list submitted by the Forester, Kendujuani Section do not tally with the girth-wise enumeration of trees mentioned in Sl. No.4(ii) of Part-II Application Form. Further the tree enumeration list not authenticated by you, Range Officer, Kendumundi and Tahasildar, Thakurmunda.

iii) Justification of non-availability of Non-Forest Land for relocation of villages is wanting.

iv) In Sl.No.8(ii) of Part-II Application Form you have mentioned that it is a part of Similipal W.L. Sanctuary but in Sl.No.8(iii) you have mentioned it is not located within eco-sensitive zone which may be clarified.

v) Clarification of the exemption of Compensatory Afforestation of this project is wanting.


vi) In the project details, number of families proposed to be rehabilitated from each of the villages presently located within the core and buffer area of Similipal Tiger Reserve has not been mentioned and no approved rehabilitation and resettlement plan is enclosed in the DP.

vii) The Part-II and Site Inspection Reports should have the original signature in all copies.

Hence, the Diversion Proposal in 5(five) copies is returned herewith for resubmission after due compliance. Further you are requested to submit the Diversion Proposal in Cover File.


