


Madam,

With reference to the subject and reference cited above, I am directed to request to submit the following additional documents / clarification etc at the earliest for further consideration of the proposal under FCA, 1980;

- As the proposed forest area is passing through ESZ of Pocharam WLS, comments
 of the Chief Wildlife Warden on likely impact on wildlife due to the subject
 project and proper wildlife mitigation measures duly approved by the CWLW
 may be submitted.
- 2. As per rule 6 (3) (c) of Forest Conservation Act, 1980 and FC Rules, 2003 (Amended up to August 2017), the document and part II are to be signed by the DFO concerned. In the instant proposal, it is noticed that Site Inspection Report and Part II signed by FDO. Hence same may be rectified and resubmit the all such documents which are mandatorily to be filled / signed by the DFO concerned.
- 3. It appears that an alternate road existing to the proposed road alignment. Hence, map clearly depicting the alternatives examined along with short write-up on each alignment (i.e. actual area involved, no of trees to be felled, cost etc), may be submitted.

4. It is noticed that, there is some breaking up of land seen adjacent to the proposed road in the forest area (as per google image of 2020). Hence may submit detailed report on the same.
